August 25, 2020 - The County Commission approved transmittal of proposed amendment PCT 20-5 to State review agencies; and November 10, 2020 - Set adoption Public Hearing for December 1, 2020.

Summary Explanation/Background

The Planning Council, as the Local Planning Agency (LPA) responsible for the Broward County Land Use Plan, considered the following proposed text amendment, PCT 20-5, at its February 27, 2020 public hearing and 1) recommended approval of the proposed affordable housing methodology (Vote of the Planning Council; 15-3; Yes: Blattner, Breslau, Brunson, Castillo, Fernandez, Gomez, Good, Graham, Hardin, Maxey, Railey, Rich, Rosenof, Ryan and Williams. No: DiGiorgio, Parness and Stermer) and 2) recommended denial to require evaluation of each income category (Vote of the Planning Council; 17-1; Yes: Blattner, Breslau, Brunson, Castillo, DiGiorgio, Fernandez, Gomez, Good, Graham, Hardin, Maxey, Parness, Railey, Rosenof, Ryan, Williams and Stermer. No: Rich); however the Planning Council recommended approval of both the proposed affordable housing methodology and to require the evaluation of each income category at its October 22, 2020 public hearing: (Vote of the Planning Council; 15-1; Yes: Blackwelder, Blattner, Breslau, Castillo, DiGiorgio, Fernandez, Gomez, Good, Graham, Hardin, Maxey, Parness, Railey, Rich and Ryan.
