Summary Explanation/Background

PUBLIC WORKS DEPARTMENT/HIGHWAY CONSTRUCTION AND ENGINEERING DIVISION RECOMMENDS APPROVAL

This item supports the Board of County Commissioners' Value of "cooperatively delivering an efficient and accessible regional intermodal transportation network" with the Goal of supporting "the development, design and construction of sustainable, multi-modal transportation facilities throughout the County, to meet the demands of residents, travelers, and businesses."

The Florida Department of Transportation (FDOT) is currently in the design process for improvements to SR 817/University Drive from north of SR 84 to north of NW 1st Street.

As part of the Broward County Mobility Advancement Program, Adaptive Traffic Control Systems (ATCS) are being installed throughout the County. The FDOT roadway improvements project along University Drive overlaps with the County's planned ATCS installations along SR 817/University Drive from Peters Road to Broward Boulevard. Broward County and FDOT have determined that it is in their mutual interest to include the County's work within the FDOT project. Broward County's contribution to FDOT provides for engineering design services for County ATCS deployment within the limits of the FDOT project.

The Agreement will provide for the County to pay FDOT the estimated amount of \$56,509 to incorporate the County's Adaptive Traffic Control System design into the FDOT's design scope of work. The total estimated cost of FDOT's design work including the County project is \$1,413,862.

The Agreement has been reviewed and approved as to form by the County Attorney's Office.
