Summary Explanation/Background

The Planning Council, as the Local Planning Agency (LPA) responsible for the Broward County Land Use Plan, considered the following proposed small scale amendment, PC 21-4, at its January 28, 2021, public hearing and **recommended approval, including not requiring a second Planning Council public hearing, and recognizing the applicant's voluntary commitment to restrict 15 percent of the proposed dwelling units as moderate-income affordable housing units for a minimum of 30 years** (Vote of the Planning Council; Unanimous: 15-0; Blackwelder, Breslau, Brunson, Castillo, Fernandez, Gomez, Graham, Grosso, Hardin, Maxey, Railey, Rich, Rosenof, Williams and DiGiorgio):

AMENDMENT PC 21-4

Amendment to the Broward County Land Use Plan - City of Dania Beach

From Low-Medium (10) Residential to High (50) Residential

Approximately 5.5 acres; generally located east of State Road 7/U.S. 441, between the C-11/South New River Canal and Griffin Road.
