The Planning Council, at its January 28, 2021 public hearing, **recommended approval** to amend Article 3 of the Administrative Rules Document: BrowardNext for consistency with the proposed adoption of Broward County Land Use Plan Policy 2.16.4 to permit residential density with an affordable housing component within specified areas of the "Commerce" and "Activity Center" land use designations (Vote of the Planning Council; Unanimous; 15-0: Blackwelder, Breslau, Brunson, Castillo, Fernandez, Gomez, Graham, Grosso, Hardin, Maxey, Railey, Rich, Rosenof, Williams and DiGiorgio).
