THE BROWARD REGIONAL EMERGENCY MEDICAL SERVICES (EMS) COUNCIL, THROUGH THE OFFICE OF MEDICAL EXAMINER AND TRAUMA SERVICES, RECOMMENDS APPROVAL.

The Broward Regional EMS Council makes recommendations to the Board on issues concerning the delivery of emergency and nonemergency care and transportation to the citizens and visitors of Broward County.

Each member of the Council represents a specific category based upon expertise within a given area. The County Commission appoints Council members, and each serve for a four-year term, or through the expiration of vacant position's term, at the pleasure of the Board of County Commissioners.

The Broward Regional EMS Council met on March 4, 2021, and approved forwarding the following nominations for appointments:

- Vanessa Quiles, representing Nurses: Emergency Room (4-6-2021 to 4-6-2025)
- Andrew Masters, representing Critical Incident Stress Management (4-6-2021 to 4-6-2025)
- Jason Smith, representing Fire and Paramedic, Union Representative (4-6-2021 to 4-6-2025)
