This item relates to activities in the Broward Municipal Services District. The Broward Municipal Services District (BMSD), formerly known as Unincorporated Broward County, consists of 11.4 square miles and has a population of approximately 15,006.* The Broward County Board of County Commissioners is the governing body of the BMSD, and provides municipal services for the area, including business and housing development, library and park facilities, roadway maintenance, street enhancements, and zoning and code enforcement.

The Resolution will convey a triangularly-shaped road easement, measuring approximately 20 feet by 20 feet, from M & R Hometrust Builders LLC to Broward County (Exhibit 1). The easement is located at the southwest corner of NW 29th Terrace and NW 10th Court, which are both County roads in the Broward Municipal Services District, as shown in Exhibit 2. The executed Road Easement (Exhibit 3) is required to provide adequate sight distance for safety and pedestrian enhancements at this intersection in the future.

The Resolution and Road Easement have been reviewed and approved as to form by the County Attorney's Office.
