## **Summary Explanation/Background**

THE FINANCE AND ADMINISTRATIVE SERVICES DEPARTMENT AND THE HUMAN RESOURCES DIVISION RECOMMEND APPROVAL OF THE ABOVE MOTION.

This item seeks approval of one non-financial agreement that provides economically disadvantaged youth with summer work experience at no cost to the County. The program is possible through funds made available through the Children's Services Council of Broward and CareerSource Broward (CSBD).

The Agreement covers three summer periods from the date of execution by the parties through September 30, 2024 (Exhibit 1). The summer work experience program is for a period of eight to ten weeks based upon CSBD fund availability. CSBD covers all costs, and no County funding is involved.

The Agreement provides for County agencies to submit job order requests to CSBD. CSBD will match youth to the requests based upon expressed interests by the youth, location, and age. CSBD will pay the youths' wages, serve as employer of record, and provide workers' compensation insurance. Both the youth and the County will benefit from the program.

The Agreement has been reviewed and approved as to form by the Office of the County Attorney.
