#### Why Action is Necessary

- B. Section 129.06(2)(d), Florida Statutes, requires a budget resolution to recognize revenue.
- C. Authorizes the County Administrator to execute amendments that revise scopes of services in certain agreements.
- D. A waiver of a conflict arising under Section 112.313 (7) (a), Florida Statutes, requires two-thirds approval by the Commission.

## **What Action Accomplishes**

Adoption and approval of Motions A through C provides funding for services to persons experiencing homelessness and for administrative services to assist with increasing the capacity of the local homeless continuum of care.

Approval of Motion D waives the existence of any conflicts arising under Section 112.313 (7)(a), Florida Statutes, as authorized under applicable law.

#### **Summary Explanation/Background**

THE HUMAN SERVICES DEPARTMENT AND THE COMMUNITY PARTNERSHIPS DIVISION RECOMMEND APPROVAL OF THE ABOVE MOTIONS.

These actions support the Commission's value of "approaching human services collaboratively and compassionately, with special emphasis on the most vulnerable" and the goal to "collaborate with public and private partners to find creative, equitable, and responsible solutions to systemic community problems, especially permanent, supportive housing for persons experiencing, or at risk of, homelessness." The grant funding supports services to prevent, prepare for, and respond to COVID-19 among persons experiencing homelessness.

The Commission approved the allocation of DCF Unified Homelessness funds for state fiscal year 2019-2020 on June 11, 2019, (Item No. 18) and for state fiscal year 2020-2021 on October 20, 2020 (Item No. 10), to specified service providers for emergency shelter services, rapid re-housing services, and supportive services that assist persons experiencing homelessness in Broward County, and for administrative services. The Commission also authorized the County Administrator to execute DCF Grant Contract No. JP003. On November 10, 2020 (Item No. 81), the Commission authorized the appropriation and disbursement of DCF funds to prevent, prepare for, and respond to COVID-19 in the estimated amount of \$1,170,000.

This agenda item requests Commission approval of the appropriation and disbursement of state fiscal year 2021-2022 DCF Unified Homeless grant funds in the estimated amount of \$2,865,920 to service providers specified in Exhibit 1, Attachment A. The DCF grant award includes funds to be retained by Broward County for the non-congregate shelter and for grant administration. In addition, Commission approval is requested to expand the scopes of services in certain agreements, identified in Exhibit 3, for the specified service providers to assist persons experiencing homelessness in the prevention and response to COVID-19 effective retroactively from August 1, 2020 through June 30, 2021.

Approval of this item would give rise to certain employment conflicts under Section 112.313(7)(a), Florida Statutes, which provides that "no public officer ... shall have or hold any employment or contractual relationship with any business entity ... which ... is ... doing business with an agency of which he or she is an officer or employee." In accordance with Section 112.313(12), Florida Statutes, Commission approval is required to waive any conflict of interest arising under Section 112.313(7)(a), Florida Statutes. An effective waiver requires two-thirds vote of the Commission after disclosure of the conflicting relationship (Motion D) in accordance with Section 112.313(12), Florida Statutes. Forms 4A, Disclosure of Business Transaction, Relationship, or Interest, are attached to this report as Exhibit 4 and constitute full disclosure of any existing conflicts.
