MOTION TO ENACT Ordinance amending the Broward County Comprehensive Plan to adopt Broward County Land Use Plan amendment PCNRM 21-1 to amend the Historic Sites Map of the Natural Resource Map Series, pursuant to Section 163.3184, Florida Statutes, as amended, the substance of which is as follows:

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, ADOPTING AN AMENDMENT TO THE HISTORIC SITES MAP OF THE BROWARD COUNTY COMPREHENSIVE PLAN; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

#### Why Action is Necessary

Pursuant to Section 163.3184, Florida Statutes, as amended, Broward County Comprehensive Plan amendments shall be adopted by Ordinance by the Broward County Board of County Commissioners, serving as the local governing body.

#### What Action Accomplishes

The Ordinance adopts PCNRM 21-1, which is an amendment to the Historic Sites Map of the Broward County Land Use Plan Natural Resource Map Series, pursuant to Section 163.3184, Florida

Statutes, as amended.

June 1, 2021 - The County Commission approved transmittal of proposed Broward County Land Use Plan amendment PCNRM 21-1 to designated State review agencies; and August 24, 2021 - Set adoption Public Hearing for September 9, 2021.
