**Summary Explanation/Background**

THE RESILIENT ENVIRONMENT DEPARTMENT AND THE ANIMAL CARE DIVISION RECOMMEND APPROVAL OF THE ABOVE MOTIONS

The Animal Care Division has received a generous donation from the Stuart B. Reese Living Trust in the amount of \$500,000. These funds will be used to augment lifesaving programs, including \$200,000 to help offset the cost of field vehicle upgrades from trucks to vans (Exhibits 1 - 4). (The vans provide improved safety and transport comfort for pets impounded by the Division.)

Inherent in the motion is authorization for the County Administrator to take all administrative and budgetary actions required to complete the donation. The Resolution is approved as to form by the County Attorney's Office.
