## **Summary Explanation/Background**

This Resolution proposes an amendment to the Broward County Charter that, to be effective, must be approved by the Broward County electorate during the 2022 General Election. If approved, the proposal would establish the Broward County Mayor as a Charter Office elected countywide beginning in November 2024. The Mayor would have a salary of \$220,000 (subsequently adjusted for inflation), be limited to two (2) consecutive four year terms, and be prohibited from holding outside employment. The Charter amendment would not, in any way, expand the duties and obligations of the Mayor as stated in the current Charter.

Six (6) affirmative votes are required to place this proposed Charter amendment on the ballot.

#### Fiscal Impact/Cost Summary

Pursuant to Section 11.07 of the Broward County Charter, the County Auditor has reviewed the proposed amendment to the Charter and determined that the amendment would result in additional costs in the amount of approximately \$707,000 per year (Exhibit 2).
