AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO PRIVATE PARKING TICKETS; REPEALING SECTION 20-164.2 OF THE BROWARD COUNTY CODE OF ORDINANCES ("CODE"); AMENDING SECTION 8½-16 OF THE CODE REGARDING CIVIL PENALTIES FOR VIOLATIONS OF SECTION 20-164.2; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE. (Sponsored by the Board of County Commissioners)

### Why Action is Necessary

A Resolution directing the County Administrator to publish notice of public hearing to consider enactment of the Ordinance was adopted by the Board of County Commissioners at its meeting of April 26, 2022.

### Previous Action Taken

### Summary Explanation/Background

On September 21, 2021, the Board enacted an Ordinance creating Section 20-164.2 of the Broward County Code of Ordinances prohibiting private parking facilities from issuing private parking tickets to motor vehicles. During the 2022 legislative session, the Legislature enacted Committee Substitute/Senate Bill 1380 ("CS/SB 1380"), which prohibits counties and municipalities from enacting ordinances restricting private property owners or operators from establishing their own rules and rates to govern private parking on their property. CS/SB 1380 declares all prohibited local ordinances null and void. CS/SB 1380 was signed by the Governor on June 7, 2022.
