## **Summary Explanation/Background**

THE PORT EVERGLADES DEPARTMENT RECOMMENDS APPROVAL.

This item supports the Broward County Board of County Commissioners' ("Board") Value of "Ensuring economic opportunities for all people and businesses in Broward" and the Goal to "Increase the economic strength and impact of revenue generating County enterprises balancing economic, environmental, and community needs."

Section 2106 of the Water Resources Reform and Development Act of 2014 ("WRRDA") established a "donor port" program to address disparities between the amount of Harbor Maintenance Tax collected at some ports and the dollars spent from the Harbor Maintenance Trust Fund at that port. Ports receiving less than 25% of the taxes collected at that port and meeting certain other criteria were designated as "donor ports."

The U.S. Army Corps of Engineers ("USACE") Fiscal Year 2022 Work Plan included \$213,840 for Port Everglades as a qualified "donor port." Activities that Port Everglades may use these funds for include: maintenance dredging of non-federal berthing areas and access channels; placement of material dredged from berthing areas and access channels; maintenance dredging and placement of legacy-contaminated sediment and sediment unsuitable for open water placement, if such dredging and placement would benefit commercial navigation at the harbor and such sediment is located in and affects the maintenance of a federal navigation project; necessary engineering, design, and supervision and administration, including hydrographic surveys; dredged material testing and monitoring; permitting; and environmental documentation. A Memorandum of Agreement ("MOA") is required to transfer the funds to Port Everglades.

The MOA has been reviewed and approved as to form by the Office of the County Attorney and will be executed by the federal government after approval by the Board. The MOA is on the federal government's form and does not include the County's standard terms and conditions.
