## **Summary Explanation/Background**

Section 43.57 of the Broward County Administrative Code ("Administrative Code") establishes the fees charged by the Office of Regional Emergency Services and Communications when it reviews Comprehensive Emergency Management Plans (CEMPs) and Emergency Environmental Control Plans (EECPs) as required by law. The plans outline the emergency response procedures established by municipalities, assisted living facilities, and other entities. Currently, these fees are only payable by certified check or bank draft. This limitation delays payment processing times and hinders the ability of the agency to provide this service. The proposed amendment will allow the agency to accept electronic forms of payment approved by the County Administrator or the Chief Financial Officer.
