The Resolution allows the County to accept a utility easement lying over and across a portion of Parcel "I", of Ravenswood 26th Ave FLL Airport Plat as recorded in Plat Book 162, Page 9, of the Public Records of Broward County, Florida. This item relates to a new utility construction project within Water and Wastewater Services District 3A potable water and sanitary sewer service area. This easement is required so that Broward County can maintain the public water and sewer mains and associated appurtenances serving the public in perpetuity.
