#### Requested Action

<u>MOTION TO ADOPT</u> Resolution directing the County Administrator to publish Notice of Public Hearing to be held on Tuesday, September 21, 2021, at 10:00 a.m., in Room 422 of the Governmental Center to consider adoption of a proposed Resolution Amending the Broward County Administrative Code, the title of which is as follows:

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO HOLIDAYS; AMENDING SECTION 14.227 OF THE BROWARD COUNTY ADMINISTRATIVE CODE ("ADMINISTRATIVE CODE"); DESIGNATING JUNE 19 ("JUNETEENTH") AS AN OFFICIAL PAID HOLIDAY FOR COUNTY EMPLOYEES; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE ADMINISTRATIVE CODE, AND AN EFFECTIVE DATE. #### Why Action is Necessary

The Broward County Charter requires the posting of notice and a public hearing for adoption of amendments to the Broward County Administrative Code.

#### What Action Accomplishes

Enables the setting of a public hearing during which the Board may consider adopting a Resolution amending the Administrative Code to recognize Juneteenth as a paid County holiday.

#### Previous Action Taken

#### Summary Explanation/Background

June 19, also known as Juneteenth, commemorates the date in 1865 when the Union Army informed enslaved African Americans in Galveston, Texas, of their freedom from slavery and the end of the Civil War. Juneteenth is recognized as a holiday in more than 45 states, with several state and local governments recognizing Juneteenth as a paid day of leave for their employees. On June 17, 2021, Juneteenth was declared a paid federal holiday.

If approved, the Administrative Code would be amended to establish Juneteenth as a paid County holiday.

Under applicable Board rules, with certain exceptions, an item previously considered by the Board may not be placed on a meeting agenda within six months after the Board's prior consideration. This item was previously considered by the Board most recently on February 23, 2021, which is more than six months ago.
