1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, AUTHORIZING APPROPRIATION AND DISBURSEMENT OF
3 FLORIDA DEPARTMENT OF CHILDREN AND FAMILIES FISCAL YEAR 2025-2026
4 GRANT FUNDS IN THE AGGREGATE AMOUNT OF \$1,085,268 TO SPECIFIED
5 SERVICE PROVIDERS FOR THE PROVISION OF EMERGENCY SHELTER
6 SERVICES, RAPID REHOUSING SERVICES, RENT PAYMENT ASSISTANCE, AND
7 SUPPORTIVE SERVICES TO INDIVIDUALS AND FAMILIES EXPERIENCING
8 HOMELESSNESS IN BROWARD COUNTY AND FOR ADMINISTRATIVE SERVICES;
9 AUTHORIZING THE COUNTY ADMINISTRATOR TO EXECUTE AGREEMENTS WITH
10 THE SPECIFIED SERVICE PROVIDERS AND TO TAKE ALL NECESSARY
11 ADMINISTRATIVE AND BUDGETARY ACTIONS TO IMPLEMENT THE AGREEMENTS
12 WITH THE PROVIDERS; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE
13 DATE.

15 WHEREAS, the Florida Department of Children and Families (“DCF”) has awarded
16 multiyear funding to Broward County under Unified Homelessness Grant Contract LP028,
17 comprising the Emergency Solutions Grant, Challenge Grant, and Staffing Grant
18 (collectively, “UHG Funding”);

19 WHEREAS, UHG Funding facilitates the development and implementation of the
20 continuum of care plan and assists with the coordination and delivery of services that
21 address the needs of individuals and families experiencing homelessness in

22 Broward County, including emergency shelter services, rapid rehousing services, rent
23 payment assistance, supportive services, and administrative services (collectively,
24 the “Services”);

25 WHEREAS, UHG Funding also supplements the cost of staffing expenses and
26 administrative support to the Broward County Homeless Continuum of Care Board;

27 WHEREAS, the Board of County Commissioners of Broward County, Florida
28 (“Board”), desires to appropriate and disburse UHG Funding to specified service
29 providers for the provision of Services for DCF fiscal year 2025-2026 (“DCF FY26”),
30 effective July 1, 2025, through June 30, 2026; and

31 WHEREAS, the Board finds that the Services to be funded benefit the residents of
32 Broward County and serve a public purpose, NOW, THEREFORE,

33 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
34 BROWARD COUNTY, FLORIDA:

35 Section 1. The Board hereby authorizes appropriation and disbursement of
36 UHG Funding for DCF FY26 funds in the aggregate amount of One Million Eighty-five
37 Thousand Two Hundred Sixty-eight Dollars (\$1,085,268) as set forth in Attachment A.

38 Section 2. The County Administrator is hereby authorized to execute the new
39 UHG-funded agreements (using the applicable Board-approved standard form
40 agreement) with the service providers identified with an “N” in Attachment A. The Broward
41 County Administrator is hereby authorized to take all necessary administrative and
42 budgetary actions to implement the new agreements set forth in Attachment A. Nothing
43 in this Resolution alters the requirement that agreements or their amendments be
44 reviewed and approved for legal sufficiency by the County Attorney’s Office before

execution by the County Administrator. Any material deviations from the applicable Board-approved agreement must be presented to the Board for approval.

Section 3. Severability.

If any portion of this Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution. If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Resolution to any other individual, group, entity, property, or circumstance.

Section 4. Effective Date.

This Resolution is effective upon adoption.
