Dear Dr. Taylor:

The purpose of this letter is to inform you of the agreed upon allocation of the Fiscal Year (FY) 2025 Section 5307 and Section 5340 for the Miami Florida Urbanized Area (UZA). The Federal Transit Administration (FTA) posted Apportionment Tables for FY 2025 on its website on May 5, 2025 allocating the Miami UZA Section 5307 funds in the amount of \$159,056,392 and Section 5340 funds in the amount of \$26,054,716.

The allocations were based on formulas and values as established by Table 5. The following table delineates the total allocation amount for each transit agency:
