1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, REGARDING RELEASE PETITION NO. 2022-V-10, RELEASING
3 A 75 FOOT WIDE STORMWATER STORAGE DRAINAGE EASEMENT RECORDED AT
4 OFFICIAL RECORDS BOOK 16653, PAGE 671, AND A PORTION OF A 15 FOOT WIDE
5 DRAINAGE EASEMENT RECORDED AT OFFICIAL RECORDS BOOK 16653, PAGE
6 664, ALL LYING WITHIN PARCEL A OF ANDREWS PREMIER BUSINESS PARK (PLAT
7 BOOK 183, PAGES 1-2); AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE
8 DATE.

10 WHEREAS, pursuant to a Notice of Public Hearing, duly and regularly advertised
11 in accordance with law, a public hearing was held in the Commission Meeting Room 422,
12 Broward County Governmental Center East, located at 115 South Andrews Avenue, Fort
13 Lauderdale, Florida, on August 21, 2025, at 10:00 a.m., to consider the advisability of
14 releasing a 75 foot wide stormwater storage drainage easement recorded at Official
15 Records Book 16653, Page 671, and a portion of a 15 foot wide drainage easement
16 recorded at Official Records Book 16653, Page 664, lying with Parcel A of Andrews
17 Premier Business Park (Plat Book 183, Pages 1-2), all as included in the Official Records
18 of Broward County, Florida, and generally located on the west side of North Andrews
19 Avenue between Northwest 15 Street and Northwest 18 Street, in the City Pompano
20 Beach, Florida, said lands situate, being, and lying in Broward County, Florida, as
21 described in Exhibit A, attached hereto; and

22 WHEREAS, after hearing all interested parties and determining that the proposed
23 action will not materially interfere with the Broward County road system or adversely affect
24 the interests of the citizens of Broward County, and will not affect the ownership of or
25 deprive any person of convenient access to his/her premises, in accordance with
26 Section 27.69 of the Broward County Administrative Code, it was determined that it would
27 be in the best interest of all concerned to release the rights associated with the
28 aforementioned land as described in Exhibit A, all situate, being, and lying in Broward
29 County, Florida, NOW, THEREFORE,

30 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
31 BROWARD COUNTY, FLORIDA:

32 Section 1. Release.

33 Pursuant to Section 27.69 of the Broward County Administrative Code, said Board
34 hereby releases the rights associated with the Easements on the land as set forth in
35 Release Petition No. 2022-V-10, as described in Exhibit A, all situate, being, and lying in
36 Broward County, Florida.

37 Section 2. Severability.

38 If any portion of this Resolution is determined by any court to be invalid, the invalid
39 portion will be stricken, and such striking will not affect the validity of the remainder of this
40 Resolution. If any court determines that this Resolution, in whole or in part, cannot be
41 legally applied to any individual, group, entity, property, or circumstance, such
42 determination will not affect the applicability of this Resolution to any other individual,
43 group, entity, property, or circumstance.

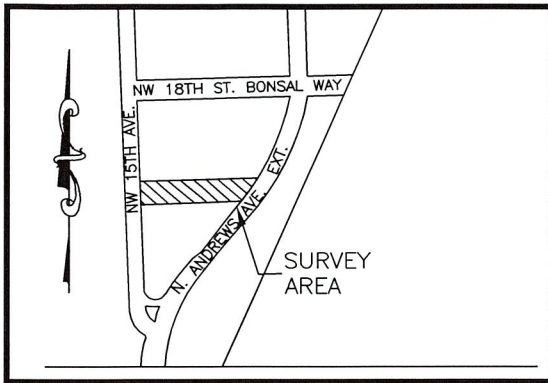

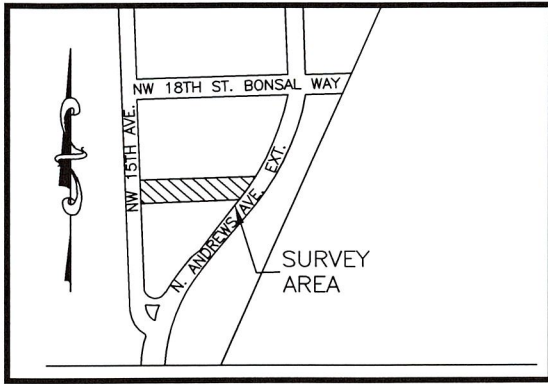

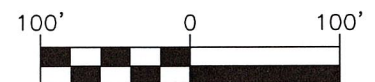
