A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL APPROVING AN "INTERLOCAL AGREEMENT WITH BROWARD COUNTY FOR EMERGENCY/NONGUARANTEED SUPPLEMENTAL SUPPORT BUILDING CODE SERVICES TO BE PERFORMED BY THE BROWARD COUNTY BUILDING CODE DIVISION OF THE RESILIENT ENVIRONMENT DEPARTMENT" FOR BUILDING OFFICIAL, PLAN REVIEW, PERMIT INSPECTIONS, CODE ENFORCEMENT AND OTHER SERVICES RELATED TO BUILDING; AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT AND FOR OTHER PURPOSES; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY INTERIM CITY MANAGER KENNIE HOBBS, JR.).

WHEREAS, Section 163.01, Florida Statutes, permits public agencies to enter interlocal agreements with each other to jointly exercise any power, privilege, or authority, which such agencies share in common and which each might exercise separately; and

WHEREAS, Broward County maintains a Resilient Environment Department that includes a Building Code Division ("BCD"), which conducts building official, plan review, permit inspections, code enforcement, and other services relating to building; and

WHEREAS, the City is desirous of procuring the services provided by the BCD on properties within the jurisdiction of the City; and

WHEREAS, Broward County, through BCD, is willing to perform such services as set forth in the Interlocal Agreement, attached hereto as **Exhibit** "A".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The City Commission hereby approves the "Interlocal Agreement with Broward County for Emergency/NonGuaranteed Supplemental Support Building Services to be Performed by the Broward County Building Code Division of the Resilient Environment Department", said Interlocal Agreement, is attached hereto as Exhibit "A".

<u>SECTION 2.</u> The Mayor is authorized to execute the Interlocal Agreement on behalf of the City, and the Interim City Manager or designee is authorized to do all things necessary to effectuate this Resolution.

<u>SECTION</u>. This Resolution shall take effect immediately upon its passage.
