

RESOLUTION NO. 2025-09-04

A RESOLUTION OF THE PERFORMING ARTS CENTER AUTHORITY, AN INDEPENDENT SPECIAL DISTRICT IN THE STATE OF FLORIDA; ADOPTING ITS FINAL OPERATING BUDGET FOR FISCAL YEAR 2026 FOR THE PERIOD COMMENCING OCTOBER 1, 2025, THROUGH SEPTEMBER 30, 2026; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Performing Arts Center Authority, an independent special district in the State of Florida ("PACA") has its main office at the Broward Center for the Performing Arts in Fort Lauderdale, Broward County, Florida; and

WHEREAS, PACA's governing Board ("Board") is empowered to adopt its amended budget under Section 3 [Subsection 6(1)] of Chapter 2005-335, Laws of Florida ("PACA's Special Act"), subject to approval by Broward County's Commission and Fort Lauderdale's City Commission; and

WHEREAS, PACA's Board desires to adopt PACA's budget for Fiscal Year 2026 for the period commencing October 1, 2025, through September 30, 2026; and

WHEREAS, a copy of the budget is either attached to the Resolution or simultaneously accompanies the Resolution on the Board's agenda, NOW, THEREFORE,

BE IT RESOLVED BY THE PERFORMING ARTS CENTER AUTHORITY:

Section 1. ADOPTION.

The Board adopts PACA's operating budget for Fiscal Year 2026 which commences on October 1, 2025, through September 30, 2026. The adopted budget is subject to approval of the Broward County's Commission and Fort Lauderdale's City

Commission. A copy of the budget is either attached to the Resolution or simultaneously accompanies the Resolution on the Board's agenda.

Section 2. SEVERABILITY.

If any portion of this Resolution or the budget is determined by any Court to be invalid, the invalid portion shall be stricken, and such striking shall not affect the validity of the remainder of this Resolution or the budget. If any Court determines that this Resolution or the budget, or any portion thereof, cannot be legally applied to any individual(s), group(s), entity(ies), property(ies), or circumstance(s), such determination shall not affect the applicability of this Resolution or the budget to any other individual, group, entity, property, or circumstance.

Section 3. EFFECTIVE DATE.

This Resolution shall be effective upon its adoption.

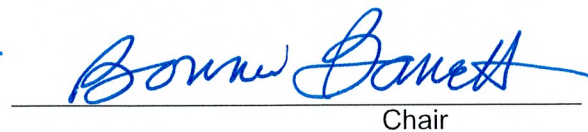
