Hello members of our planning council!

I am a resident of Pompano Beach and a 23 year resident of Broward County, who grew up in Palm Beach County. I want to start by mentioning the irony of the name Monarch hill – a landfill named after the fragile, gorgeous, endangered monarch butterfly??? That said, I am adamantly against the enlargement of the site! Monarch Hill is one of the three largest landfills in the U.S., and the only one in such a densely populated urban area. I have a friend who lives near Monarch Hill, and I have stopped visiting him because of the smell and the effect simply visiting, had on my health.

The landfill started operating before there was an EPA, and doesn't meet contemporary safety standards. Whereas present-day landfills are generally required to have a liner system that includes a layer of compacted clay with a minimum required thickness (the one in the Waste Management landfill in Austin, Texas, for example, is two feet thick) that's overlaid by a high-density polyethylene (plastic) membrane that covers the bottom and all sides. But 56% of the Monarch Hill landfill has no liner at all, and the remaining 44% has only one. Meaning that although those of us in the immediate area are exposed to the lion's share of its fumes, the entire county is affected by its contamination of our water supply. The liquid runoff from a landfill is called leachate. We don't know exactly what's in Monarch Hill's leachate now, but the study undertaken when they proposed to build a deep-water waste injection well at the site in 2016 found carcinogens, hormone disruptors, and other deadly chemicals in its runoff. There's no reason to think Monarch Hill's leachate is any less toxic now. These are substances that are unsafe at any level and have no place in the water supply of a densely populated urban area.

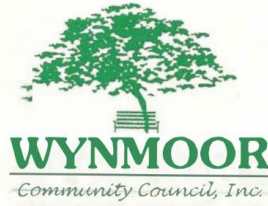
Please do NOT move forward on this expansion for all of the above reasons! DO move forward vigorously on recycling initiatives, and encouraging citizens to use less!

Dear Councilmembers,

I've lived in the vicinity of the Monarch Hill Landfill for 11 years. As one of the three largest landfills in the U.S. and the only one located in such a densely populated urban area, it's a major public nuisance. There are days I leave my house to get some exercise and turn right back around because the odor of raw sewage is permeating the neighborhood. That's unacceptable. And it's not just me. Monarch Hill is located near thousands of homes, an elementary school, a city park, and a bustling commercial area.

Waste Management's 2016 application to build a deep-water waste-injection well revealed that its runoff contained arsenic (a known carcinogen), toluene (which can affect the central nervous system, cause liver and kidney damage, and is associated with birth defects), Dieldrin (an insecticide that can affect the central nervous system), strontium-90 (a radioactive isotope that can cause cancer and anemia and impair bone growth in children), radium (another radioactive element associated with cancer, anemia, cataracts, fractured teeth, and death), and barium (which can cause breathing difficulties, kidney and heart damage, and in large amounts, paralysis and death).

There's no reason to assume that Monarch Hill's leachate is any less toxic now than it was then. These substances are unsafe at any level, and have no place in the midst of a densely populated area. Meanwhile, the bulk of the landfill has no liner, and the remainder has a liner that's insufficient by today's standards.

God help us the day the thing floods.

The landfill contains 254 acres and is a towering 225 feet high. But that's not enough; now Waste Management wants to enlarge it, which would enable the company to expand the landfill both horizontally and vertically, leading to even more of an eyesore and more air and water pollution. And don't overlook the endless stream of big, filthy exhaust-spewing trucks going to and from the facility.

Approval of Waste Management's application to expand the landfill would be a disaster for my neighborhood and limit future options for more forward-thinking, comprehensive, and appropriate ways for Broward to manage waste disposal.

The banner on Broward County's website reads, "A healthy and sustainable Broward." I urge you to make good on that promise and reject out of hand any proposals that would eventuate in the expansion of Monarch Hill. As a responsible, tax-paying American citizen--no, as a human being--I have a right to live safely and decently, as do my neighbors.

Monarch Hill is one of the three largest landfills in the U.S. and the only one in such a densely populated urban area. Aside from our property values declining which is devastating to anyone who owns a home in the area, if this expansion happens, this monstrosity not only looks awful but emits a horrendous odor and chemicals as well as chemicals used to mask this stench. This can't be good for anyone's health. They cause headaches which I have had far to many of to an awful stench that turns your stomach. We should be able to open our windows and not worry about that smell permeating our homes and nostrils.

Facts that I have recently learned:

The landfill started operating before there was an EPA, and doesn't meet contemporary safety standards. Present-day landfills are generally required to have a liner system that includes a layer of compacted clay with a minimum required thickness (the one in the Waste Management landfill in Austin, Texas, for example, is two feet thick) that's overlaid by a high-density polyethylene (plastic) membrane that covers the bottom and all sides. But 56% of the Monarch Hill landfill has no liner at all, and the remaining 44% has only one. Meaning that although those of us in the immediate area are exposed to the lion's share of its fumes, the entire county is affected by its contamination of our water supply. The liquid runoff from a landfill is called leachate. We don't know exactly what's in Monarch Hill's leachate now, but the study undertaken when they proposed to build a deep-water waste injection well at the site in 2016 found carcinogens, hormone disruptors, and other deadly chemicals in its runoff. There's no reason to think Monarch Hill's leachate is any less toxic now. These are substances that are unsafe at any level and have no place in the water supply of a densely populated urban area.

I live on the lake in Waterways, I have no doubt those carcinogens have leached into this lake. Please consider the residents needs as make this decision and vote NO on this proposed expansion. Imagine this being your own backyard, your own children affected, your pets, your property value, your health.

Dear Planning Council Members,

My name is Maria Bachir and I am your constituent in the city of Coconut Creek District C. We have resided at 3650 Coco Lake Drive since 2011 and have two children. I am also a member of Moms Clean-Air Force, a community of over one million moms and dad across the nation who advocate for clean air and water in our communities. This communication is in reference to the Monarch Hill Landfill located on Powerline Road, which is also located within 3 mile radius from our property.

During the first few years living here, we made several phone calls to the site's manager regarding the awful smell from the landfill. Fortunately in the past two years the odor has been sporadically and we have not contacted as frequently as we used to.

However, since we moved to the city of Coconut Creek, we have not stopped thinking about the possible health hazards and long term effects that this landfill could cause to my family's health and our community.

The main concerns we have about this landfill are:

- The possibility of infiltration of toxic chemicals in the water. I have spoken to the site's manager (unfortunately I do not recall his name) who assured that this landfill, despite of being over 50 years old, uses state of the art systems (pipes) and operations to avoid any underground leachate.
- Methane gas (the cause of the rotten egg smell we have experienced in the past) is another concern I have due to its toxicity and awful smell.
- The possibility of air contamination due to hydrogen sulphide.
- Drop of home values in our community. If my husband and I would have known there was a landfill so close to this property, we would have never signed the purchase agreement.

Has there been any discussions or considerations to relocate this landfill or cease its operations due to the growing population surrounding it? Has Broward County conducted any studies about the possible long term environmental and health hazard effects caused by landfills, specially in communities located within 3 to 5 miles radius

from the site?

Living so close to this landfill makes us question the air quality in our community specially for our children who enjoy the outdoor activities that the city of Coconut Creek has to offer. We live walking distance from Sabal Pines Park and love riding our bikes and walking to the park. We just hope that by choosing this community, we are not compromising our children's and our own health.

My family and our community of 169 households in Coco Lake HOA urge you to reconsider Waste Management's petition to further expand the Monarch Landfill (it's already 225 feet high). For decades, Waste Management has only monopolized the waste and recycling business in Broward County! Monarch Landfill is the largest urban landfill in the United States, nothing to be proud of. Tonight, my family and I drove by the site and the smell of methane was nauseating. We usually avoid driving by the intersection of Powerline Rd. and Wiles Rd. This evening reminded us how close we reside by this landfill and how bad this situation is getting. As a community we will fight until this landfill is shut down.
