NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is hereby amended as follows:

Lease Term: To Have and To Hold the said Premise with their appurtenances for the term beginning on October 1, 2024 and continuing through September 30, 2025 inclusive for a term of one-year. At the expiration of this term the lease will automatically renew on a year-to-year basis upon the anniversary of the Commencement Date each year thereafter for 14 (fourteen) additional years but not beyond September 30, 2039 unless or until the Government gives at least 30 days notice in writing of its intent not to renew to the Lessor.

All other terms and conditions of the lease shall remain in force and in effect.
