I. REQUEST: Provide a description of the features of the product/service or Scope of Work.

Water and Wastewater Services (WWS) requests Sole Brand, Sole Source Board Standardization of Ovivo USA, LLC (formerly EIMCO Water Technologies - EWT™); Ovivo/Eimco equipment, parts and repair services from Ovivo USA LLC (Ovivo) or it's authorized distributor at the time of purchase. Ovivo is the Original Equipment Manufacturer (OEM).

Broward County Water and Wastewater Services (WWS) has approximately \$10,000,000.00 worth of equipment in operations located at the North Regional Wastewater Treatment Plant, which consist of various sizes and types of process equipment. Equipment list includes twelve (12) Clarifiers, Gravity Thickeners, Grit Collectors, Vacuum Filters, Treatment Units, Filter Underdrains, Mechanical Mixers, Mechanical Aerators, Catwalks/ Hand Rails, Columns, Beams, Rake Arms, Gear Units, Motors, and ancillary instruments and

Sole Source/Uniqueness

- Proprietary Item - this vendor/source has the only rights to provide this service or commodity. A letter from the manufacturer or authorizing entity is included in this request.

Other/or Additional information - the County requires this sole source purchase for the following reasons.

Ovivo/ Eimco equipment is manufactured, fabricated, installed and sold by OVIVO USA, LLC. The parts are not interchangeable with any other brand and the equipment can be serviced only by Ovivo authorized service technicians. To use any other brand of equipment would require replacing expensive process equipment in its entirety; to replace the Ovivo equipment to accommodate any other brand of equipment

Business Case (Only One Reasonable-Source¹ or Only One Reasonable Brand)

- Operational Compatibility - replacement parts from alternate suppliers are not interchangeable with original part and causes equipment incompatibility. Previous findings and/or documentation is included with this request.
- Ease of Maintenance - maintenance or retooling prohibits competition. Section III, Comparative Market Research includes estimated costs associated with changing current source and/or brand.
- Follow-On - potential for continued development or enhancement with same supplier and eliminates costs incurred by using different supplier. Section III, Comparative Market Research includes estimated costs for replacing current or existing system.
- Complies with existing community and safety standards, and/or laws, rules, and regulations.
- Other/or additional information - using this only one reasonable source, only one reasonable brand purchase benefits the County for the following reasons:

Ovivo/Eimco equipment is manufactured, fabricated, installed, maintained under extended warranty and sold solely by OVIVO USA, LLC. The parts are not interchangeable with any other manufacturers equipment can only be serviced by a Factory Authorized Field Service Technicians.
As per the attached correspondence, Ovivo USA, LLC is the sole source manufacturer and exclusive distributor of all EIMCO Water Technologies parts and equipment. Ovivo USA, LLC is the original equipment manufacturer (OEM) of the subject proprietary equipment, and as such there is no other combination of OEM supplier and OEM authorized installer that can offer both factory approved components and factory approved installation services from a Florida State Licensed Contractor.

Water and Wastewater Services has over \$10,000,000 in Ovivo/Eimco equipment located at its water and wastewater treatment plants. Most of these equipment has been installed and in operations for thirty years. Therefore, replacing the equipment in order to accommodate other brand(s), would cost the County in excess of \$20 million including Consultant Engineering Services for compatibility studies of new design, modification to accommodate existing services, demolition and disposal of existing equipment and the installation of new equipment.

CERTIFICATION: I have thoroughly researched the sole source, sole brand, only one reasonable source, or only one reasonable brand justification and fully understand the implications of Section 838.22 of the Florida Statutes:

The Purchasing Agent affirms that the required due diligence has been completed through Request for Information (RFI) No. 2310-016 and recommends approval of this request. RFI No. 2310-016 was advertised on October 25, 2023 and ended on November 3, 2023 with no response. A letter dated January 12, 2024 (Exhibit 1) states that "Ovivo USA, LLC is the "Sole Source" manufacturer and exclusive distributor of all EIMCO Water Technology parts/equipment." It is recommended that the Ovivo Repair, Installation and Rehabilitation Services and associated replacement parts be procured as a Sole Source/Sole Brand, and to proceed with Board approval as an open-end standardized contract with a two-year initial term, in the estimated amount of \$2,000,000, and a potential total amount of \$5,000,000.00 for the five year term (per Requisition No. WWO0008039).
