

**SETTLEMENT AGREEMENT BETWEEN
THE FLORIDA ALCOHOL AND DRUG ABUSE ASSOCIATION, INC.
AND
Broward County, FL**

THIS SETTLEMENT AGREEMENT between the Florida Alcohol and Drug Abuse Association, Inc. (herein after referred to as the "FADAA") and the Broward County, FL (hereinafter referred to as the "Provider") is to pay for services provided to the FADAA by the Provider between July 1, 2025, and August 5, 2025, without an active agreement between the parties.

The Florida Legislature appropriated \$11,500,000 in Chapter 2025-198, Section 7, Line 2997 to provide medication-assisted treatment of substance abuse disorders in individuals involved in the criminal justice system, individuals who have a high likelihood of becoming involved in the criminal justice system, or individuals who are in court-ordered, community-based drug treatment for the period July 1, 2025, through June 30, 2026. The Office of the Court Administrator contracts with the FADAA to maintain a network of treatment providers around the State of Florida to provide said treatment. FADAA contracts with the Provider to provide medication-assisted treatment as described.

FADAA and the Provider had a contract that ended on June 30, 2025. The new contract, number OSCAFAD202527-10 was executed on August 6, 2025. The provider did provide medication-assisted treatment as described between July 1, 2025, and August 5, 2025. The FADAA wishes to uphold the intent of the Legislature by reimbursing the Provider for the Program expenses that would have otherwise been reimbursable under the state financial assistance agreement had it been in place on July 1, 2025.

The Provider continued to provide the Program services that the Legislature intended to fund in good faith, has met all requirements of the FADAA, has submitted invoices in accordance with section 215, Florida Statutes for the payment of \$ 33,015.82 for these services and has a colorable claim in support of their request for payment. Copies of these invoices are attached for reference.

THE PARTIES AGREE that:

1. Upon receipt of payment, as provided herein, the Provider, for and on behalf of its attorneys, agents, assigns, heirs, executors and administrators, does hereby and forever discharge the FADAA, the State of Florida, the State Courts System, the Office of the State Courts Administrator, and its agents, employees representatives, and attorneys, of all claims, demands, actions, causes of action, suits, damages, losses and expenses, of any and every nature whatsoever, arising out of and in any way related to this Settlement Agreement, by or on behalf of the Provider.
2. The Provider has submitted to the FADAA, the invoice(s) in the amount of \$ 33,015.82 along with any necessary documentation for payment. FADAA will make payment in full and complete satisfaction of any and all fees and costs associated with the work performed by Provider for the services provided from July 1, 2025, through August 5, 2025, and any and all claims and invoices associated attached, and any other written or verbal supplementation, including all interest, costs and fees associated with the claims and claims the Provider has or may have for the services provided.
3. This Agreement is contingent upon proper approval of the settlement agreement between the Office of the Court Administrator and FADAA by the Chief Financial Officer of the State of Florida.
4. The Parties further agree, as evidenced by their signatures and lawful executions below, that this

Agreement is binding on the Parties, and their assigns and successors in interest.

5. All terms and conditions of this Settlement Agreement as fully set forth in this document, along with its attachments, and no other material terms to this settlement exist outside of this document.
6. This Agreement, and the invoices referenced, constitute the complete understanding of the parties.

IN WITNESS THEREOF, the parties hereto have caused this two (2) page Agreement, along with its attachments, to be executed by their undersigned officials as duly authorized.
