RESOLUTION NO.

1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, AUTHORIZING APPROPRIATION AND DISBURSEMENT OF
3 U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT GRANT FUNDS IN
4 THE AMOUNT OF \$11,546,705 AND A BROWARD COUNTY MATCH CONTRIBUTION
5 OF \$2,336,609 FOR AN AGGREGATE AMOUNT OF \$13,883,314 FOR FISCAL YEARS
6 2024 AND 2025 TO SPECIFIED SERVICE PROVIDERS FOR THE PROVISION OF
7 SERVICES TO INDIVIDUALS AND FAMILIES EXPERIENCING HOMELESSNESS;
8 AUTHORIZING THE COUNTY ADMINISTRATOR TO EXECUTE NEW AGREEMENTS
9 WITH SPECIFIED SERVICE PROVIDERS AND TAKE ALL NECESSARY
10 ADMINISTRATIVE AND BUDGETARY ACTIONS TO IMPLEMENT THE
11 AGREEMENTS; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

13 WHEREAS, the U.S. Department of Housing and Urban Development (“HUD”)
14 annually awards funding to Broward County (“County”) for services including housing,
15 rental assistance, and supportive services to individuals and families experiencing
16 homelessness, continuum of care planning, homeless management information system
17 costs, and administrative services (collectively, the “Services”);

18 WHEREAS, on September 28, 2023, the County submitted its grant application to
19 HUD to continue the provision of the Services through twenty (20) local projects with
20 varying performance periods encompassing the County’s fiscal years 2024 and 2025;

21 WHEREAS, the Board of County Commissioners of Broward County, Florida
22 (“Board”), authorized the County Administrator to execute the resulting grant agreements
23 with HUD for the Services (August 22, 2023, Item No. 15);

24 WHEREAS, HUD has announced the County’s award of grant funding for the
25 Services under each project;

26 WHEREAS, the Board now desires to appropriate and disburse funding to continue
27 the provision of the Services;

28 WHEREAS, the Board further desires to authorize the County Administrator to
29 execute, on behalf of the County, new agreements with specified service providers for the
30 provision of the Services under certain projects; and

31 WHEREAS, the Board finds that the Services to be funded benefit the residents of
32 Broward County and serve a public purpose, NOW, THEREFORE,

33 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
34 BROWARD COUNTY, FLORIDA:

35 Section 1. The Board hereby authorizes appropriation and disbursement of
36 HUD grant funds in the amount of Eleven Million Five Hundred Forty-six Thousand Seven
37 Hundred Five Dollars (\$11,546,705) and a required County match contribution of Two
38 Million Three Hundred Thirty-six Thousand Six Hundred Nine Dollars (\$2,336,609) for an
39 aggregate amount of Thirteen Million Eight Hundred Eighty-three Thousand Three
40 Hundred Fourteen Dollars (\$13,883,314) for the project start dates encompassing the
41 County’s fiscal years 2024 and 2025 as set forth in Attachments A and B.

42 Section 2. The County Administrator is authorized to execute new agreements,
43 in substantially the same form as the applicable Board-approved standard form
44 agreement, with the service providers identified with an “N” in Attachment A and take all
45 necessary administrative and budgetary actions to implement the agreements. The new
46 agreements will commence on the project start dates as set forth in Attachment A. The
47 agreements with the service providers identified with an “R” in Attachment A will be
48 renewed in accordance with the terms and conditions of the agreements. Nothing in this
49 Resolution alters the requirement that agreements be reviewed and approved for legal
50 sufficiency by the Office of the County Attorney before execution by the County
51 Administrator. Any material deviations from the applicable Board-approved form
52 agreement must be presented to the Board for approval.

53 Section 3. In addition to executing the resulting grant agreements with HUD for
54 the projects listed in Attachments A and B, the County Administrator is authorized to
55 execute amendments to the HUD grant agreements, subject to review and approval for
56 legal sufficiency by the Office of the County Attorney, that do not impose any additional
57 financial obligations on the County above the County’s additional match requirement.

58 Section 4. Severability.

59 If any portion of this Resolution is determined by any court to be invalid, the invalid
60 portion will be stricken, and such striking will not affect the validity of the remainder of this
61 Resolution. If any court determines that this Resolution, in whole or in part, cannot be
62 legally applied to any individual, group, entity, property, or circumstance, such
63 determination will not affect the applicability of this Resolution to any other individual,
64 group, entity, property, or circumstance.

65 Section 5. Effective Date.

66 This Resolution is effective upon adoption.
