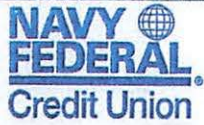

Dear County Administrator Cepero:

Filthy Organics, LLC is an organic waste recycling company based in Broward County, FL. South Florida is quickly running out of landfill space and with organics representing approximately 30% of our waste stream, it is clear there is an urgent need for robust composting solutions. With the goal of supporting the County in managing this growing crisis, Filthy Organics has identified a portion of Broward County owned property totaling approximately 8 acres as a perfect location to construct a new composting facility. Filthy Organics has interest in negotiating with Broward County a Long -Term Ground Lease to build and operate a composting site that will service clean green waste generators within Broward County and potentially include, with the County's concurrence, food waste in the future.

Filthy Organics, LLC is a Certified County Business Enterprise (CBE) as well as a Certified Service-Disabled Veteran Owned Small Business. The Filthy Organics team has been working hard since 2020 to pave the way and show that composting is a great solution to a large portion of our waste problem. Filthy Organics has been successfully operating a Community Scale Aerated Static Pile Composting facility in Broward County since 2021 and currently processes approximately 22,000 lbs. of organic waste per week. Filthy Organics is eager to expand our positive impact on the County. Filthy Organics has already partnered with the City of Deerfield Beach, the City of Coral Springs and the City of Coconut Creek, The Town of Southwest Ranches, The City of Lighthouse Point and many other private commercial and residential clients to provide collection and composting services. Some municipalities provide our doorstep collection services, some host drop off locations and some do a version of both. In addition, we are very proud of our partnership with private entities like North Broward Preparatory School, The Hollywood Hard Rock Hotel, and the Florida Panthers Arena where we collect and process food waste generated by their food service facilities.

Filthy Organics is interested in:

1. Securing a 20 Year Ground Lease on County owned property at 2780 N. Powerline Rd, Pompano Beach, FL 33069, commonly known as the "North Drop-Off Center" (Parcel #484222000220).
2. Constructing a covered Aerated Static Pile Composting Facility capable of processing a minimum of 25,000 tons per year of organics waste. From execution of the lease, design, permitting and construction should take 12 months.

3. Investing approximately \$2MM into the development of composting activity and related infrastructure.
4. Providing a reasonable payment to secure the lease.
5. Negotiating a revenue split with the County based on a share of tipping fees.
6. Complying with all Broward County Office of Economic and Small Business Development requirements.
7. Engaging with the County, Solid Waste Authority, School District and other community organizations to support educational opportunities with respect to composting on the site.

To our knowledge, this project would be the first commercial compost facility in South Florida to operate as a partnership with any local government. We see that as a huge opportunity for Broward County to be true leader in our State.

As the County is aware, this effort would divert organic waste from landfills which reduces methane emissions and creates a finished product called compost. Compost is a safe nutrient rich soil amendment that when used for landscaping and agricultural operations, significantly improves the health of our soil. Compost adds back organic matter and nutrients to our soil which improves the overall health of all of plants. This benefit alone reduces the requirement for the application of chemical fertilizers which eventually make it into our waterways and water supply. Compost also improves the root structure of plants which reduces erosion and improves the soil's ability to absorb rainwater and reduce runoff. Lastly, compost works like a sponge to hold moisture in our soil allowing our plants while reducing the need for supplemental irrigation. It's easy to see how incorporating compost into our soils makes sense for mother nature and our pocket books. Compost produced by Filthy Organics is tested regularly to ensure the highest level of safety and quality prior to its availability to the market.

The above-mentioned property is a perfect location for this operation due to a few factors:

1. It is situated on top of a closed ash landfill, next to an existing septage receiving facility and directly across the street from the Broward County Waste Water Treatment Plant.
2. It has room for growth. If utilized, the entire 8 acres on top of the closed ash landfill would allow for an additional 100,000 to 120,000 tons per year to be composted.
3. It is located in an industrial district with adequate access from Powerline Road.
4. While portions of the connecting property are traditionally set aside to accommodate hurricane debris, the use of this small portion of the property is clearly separate from the main debris collection areas and should have not impact debris management operations.

#### Due Diligence:

While we have met with the Broward County Environmental Permitting Division, the permitting for this project will be done through Florida Department of Environmental Protection. Filthy Organics has met with the appropriate agencies within FLDEP to ensure that this is a permitted use of the property.



We believe that the proposal herein is extremely beneficial to Broward County, its citizens and businesses. Moreover, it saves the County expenditures from its general funds to maintain the property. Please provide this unsolicited proposal to the Broward County Board of County Commissioners at your earliest convenience. Thank you.

## **Broward County's Need for Yard Waste Composting**

### **The Need**

- Yard trash is \*\*14% of residential\*\* and \*\*6% of commercial\*\* waste (~200,000+ tons/year).
- Current landfill disposal costs \*\*\$75/ton\*\*, the highest in the Tri-County region.
- Much of this material is still landfilled or minimally processed.
- SWA Master Plan (May 2025) identifies \*\*yard waste as the first priority\*\* for organics diversion.

### **County Goals**

- Boost recycling/diversion above \*\*60% by 2045\*\*.
- Lower disposal costs vs. landfilling.
- Build infrastructure: Master Plan recommends \*\*~380,000 TPY yard waste capacity\*\*.
- Promote circular economy: encourage use of \*\*mulch & compost in landscaping\*\*.

### **Our Proposed Site: North County Composting Facility**

- Capacity - 120,000 TPY (meets one-third of county's need).
- Technology - Aerated Static Pile (ASP) composting.
- Economics - Target tipping fee \*\*\$65/ton\*\* (below county landfill rate).
- Products - Bulk compost, colorized mulch, soil blends.
- Location - Pompano Beach North Drop-Off (county-controlled land).

### **Why It Fits**

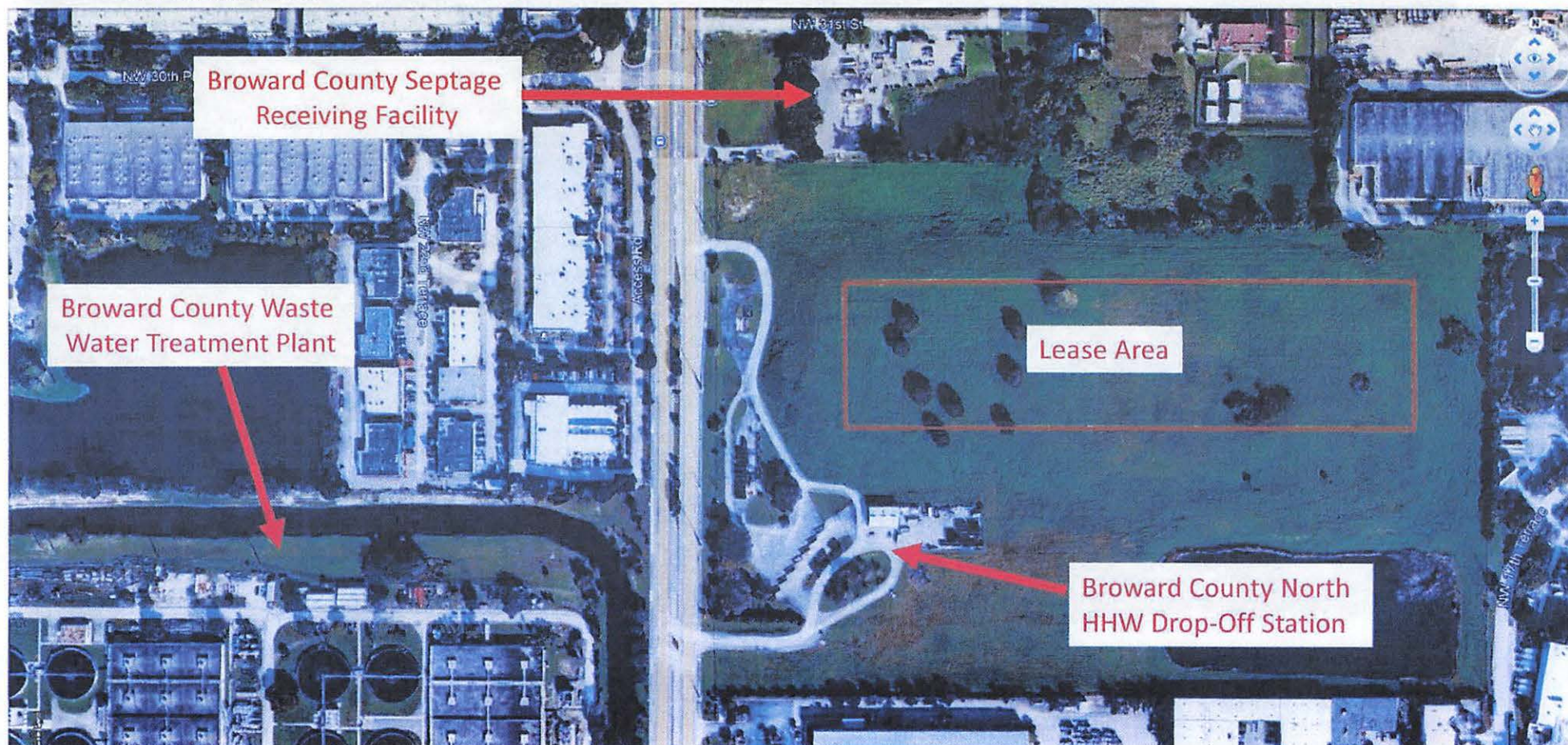
- Directly aligned with SWA Master Plan recommendations.
- Cost-competitive vs. \$75/ton landfill disposal.
- Matches documented local market demand (~107k TPY).
- Provides scalable infrastructure to help hit county diversion targets.

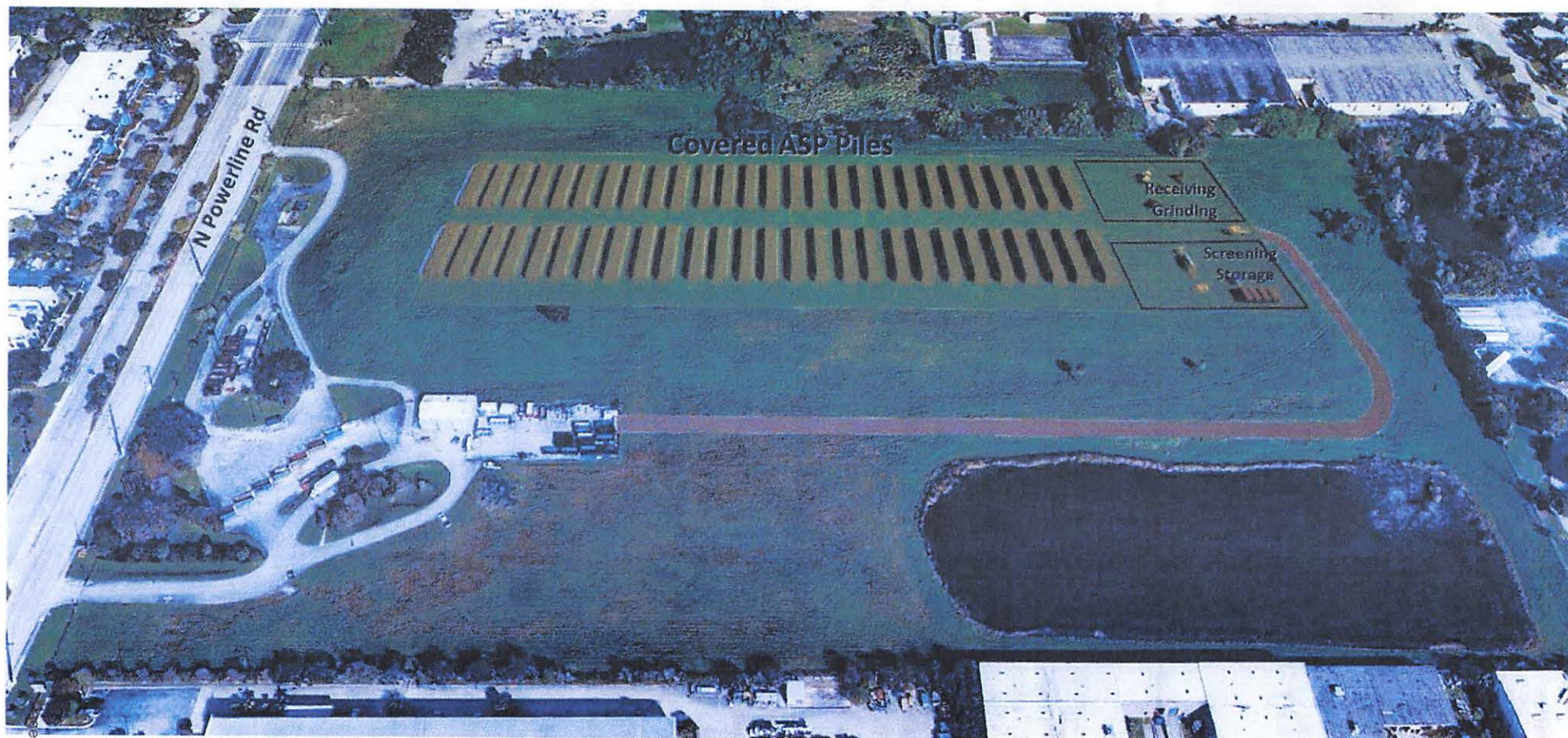
## Site Layout at 25K-30K Tons Per Year
