RESOLUTION FOR ASSISTANCE 2025
 UNDER THE FLORIDA INLAND NAVIGATION DISTRICT
 WATERWAYS ASSISTANCE PROGRAM

WHEREAS, the Board of County Commissioners of Broward County, Florida (the “Board”), is interested in carrying out the following described project for the enjoyment of the citizenry of Broward County and the State of Florida:

Project Title: Deerfield Island Basin Dock, Phase I (the “project”)

Total Estimated Cost: \$140,000

Brief Description of Project: Design and permitting of the replacement of four finger docks located in the south basin at Deerfield Island Park

AND, Florida Inland Navigation District (“FIND” or the “District”) financial assistance is required for the program mentioned above,

NOW THEREFORE, be it resolved by the Board that the project described above be authorized,

AND, be it further resolved that said Board makes application to the District in the amount of 50% of the actual cost of the project on behalf of said Board,

AND, be it further resolved by the Board that it certifies to FIND the following:

1. That it will accept the terms and conditions set forth in FIND rule 66B-2 F.A.C. and which will be a part of the Project Agreement for any assistance awarded under the attached proposal.
2. That it is in complete accord with the attached proposal and that it will carry out the project in the manner described in the proposal and any plans and specification attached thereto unless prior approval for any change has been received from the District.
3. That it has the ability and intention to finance its share of the cost of the project and that the project will be operated and maintained at the expense of said Board for public use.
4. That it will not discriminate against any person on the basis of race, color, or national origin in the use of any property or facility acquired or developed pursuant to this proposal, and shall comply with the terms and intent of the Title VI of the Civil Rights Act of 1964, P.L. 88-352 (1964) and design and construct all facilities to comply fully with statutes relating to accessibility by persons with disabilities as well as other federal, state, and local laws, rules, and requirements.

5. That it will maintain adequate financial records on the proposed project to substantiate claims for reimbursement.

6. That it will make available to FIND, if requested, a post-audit of expenses incurred on the project prior to, or in conjunction with, request for the final 10% of the funding agreed to by FIND.



PROPOSAL

The project is for the design and permitting of the replacement of four finger docks located in the south basin at Deerfield Island Park. Deerfield Island Park is the only island park in Broward County and is located on the west side of the Intracoastal Waterway and is only accessible by boat. The design for this project will be to replace the four finger docks and gangways with a single lateral 120' aluminum floating dock and an ADA-accessible 60' aluminum gangway.
