¹ This solicitation is reserved for County Business Enterprise (CBE) firms pursuant to the Broward County Business Opportunity Act of 2021, Section 1-31, Code of Ordinances, as amended ("the Business Opportunity Act"). CBEs and non-CBEs may respond to the solicitation.		
Basis of Award: Vendors must bid on all line items within each group to be considered for award. A bidder may bid on any one Group but must bid on the entire Group (all line items within the Group). Award will be made to the lowest priced, responsive, responsible bidder by total group price (sum of all items in the group). Awards may be made to a maximum of five (5) responsive, responsible vendors per group.		
² The respective vendor requested to amend their submitted unit prices, therefore was non-responsive to the pricing request for the respective group.		
³ The respective vendor did not provide LOI with 25% CBE Participation, therefore not compliant with the CBE Reserve Program requirements and deemed non-responsive.		
⁴ CBE Monetary Differential: The total Bid of the CBE Presumptive Awarder does not exceed Three Million Dollars (\$3,000,000), and does not exceed the total amount of the lowest responsive and responsible bid, as applicable, from a non-CBE by more than ten percent (10%).		
⁵ Primary Contract Award Amount: The Primary Contracts will be allocated one hundred percent (100%) of the awarded amount for the respective Groups.		
⁶ Secondary Contract Award Amount: Funds from the Primary Contracts award amount will be reallocated to the Secondary Contracts when the Primary Vendors are unable to meet the County's needs.		
⁷ Tertiary Contract Award Amount: Funds from the Primary Contract Award amount will be reallocated to the Tertiary Contracts when the Primary and Secondary Vendors are unable to meet the County's needs.		
⁸ For the purpose of the price analysis and comparison, the unit prices were compared to the unit prices of previous Contract No. GEN21.8724B1.
