STAFF REPORT

**26-NM3 – FACILITY RENAMING
COURTROOM-JUDICIAL COMPLEX**

I. Staff Findings: The Housing and Urban Planning Division (HUPD) finds the proposal to name a courtroom in honor of Judge Susan Greenhawt complies with the following criteria:

1. Historical significance.
2. Geographical identifiers.
3. Flora and fauna.
4. Individuals who have made significant, nonfinancial, humanitarian contributions at the local, state, and national level

II. Summary:

The HUPD received a request from Commissioner Lamar Fisher to rename a courtroom at the Judicial Complex, located at 201 SE 6th Street, Fort Lauderdale, FL, 33301. See Exhibit 2. The subject courtroom is located in the West building, a new 714,000-square-foot Civil/Family Courthouse that houses 77 courtrooms. See Exhibit 3.

Figure 1: General Location Map

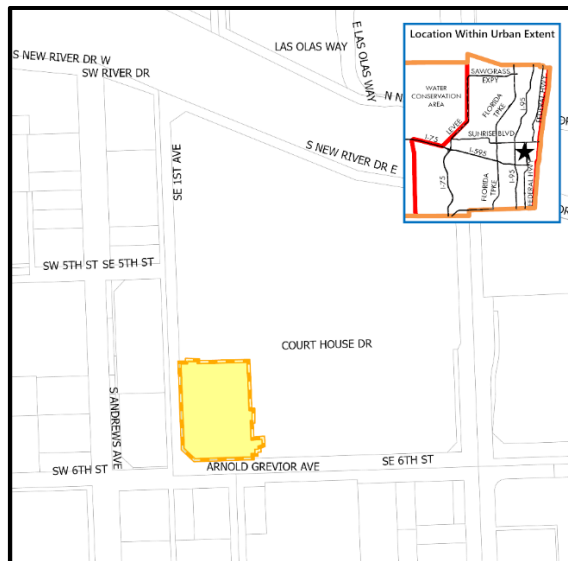
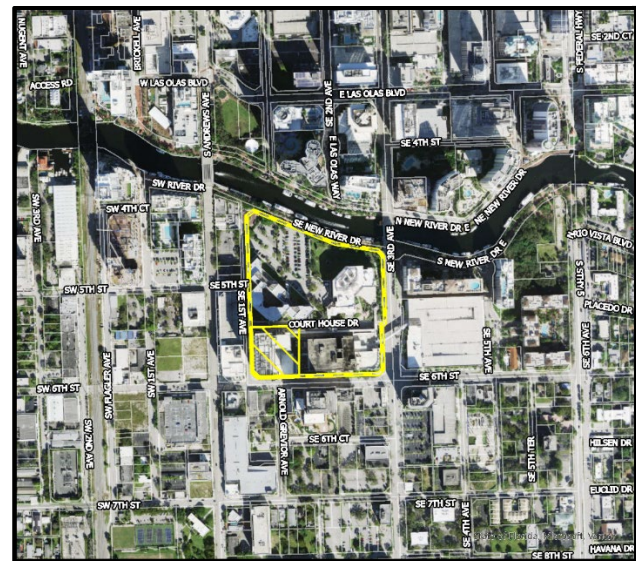


Figure 2: Aerial Map

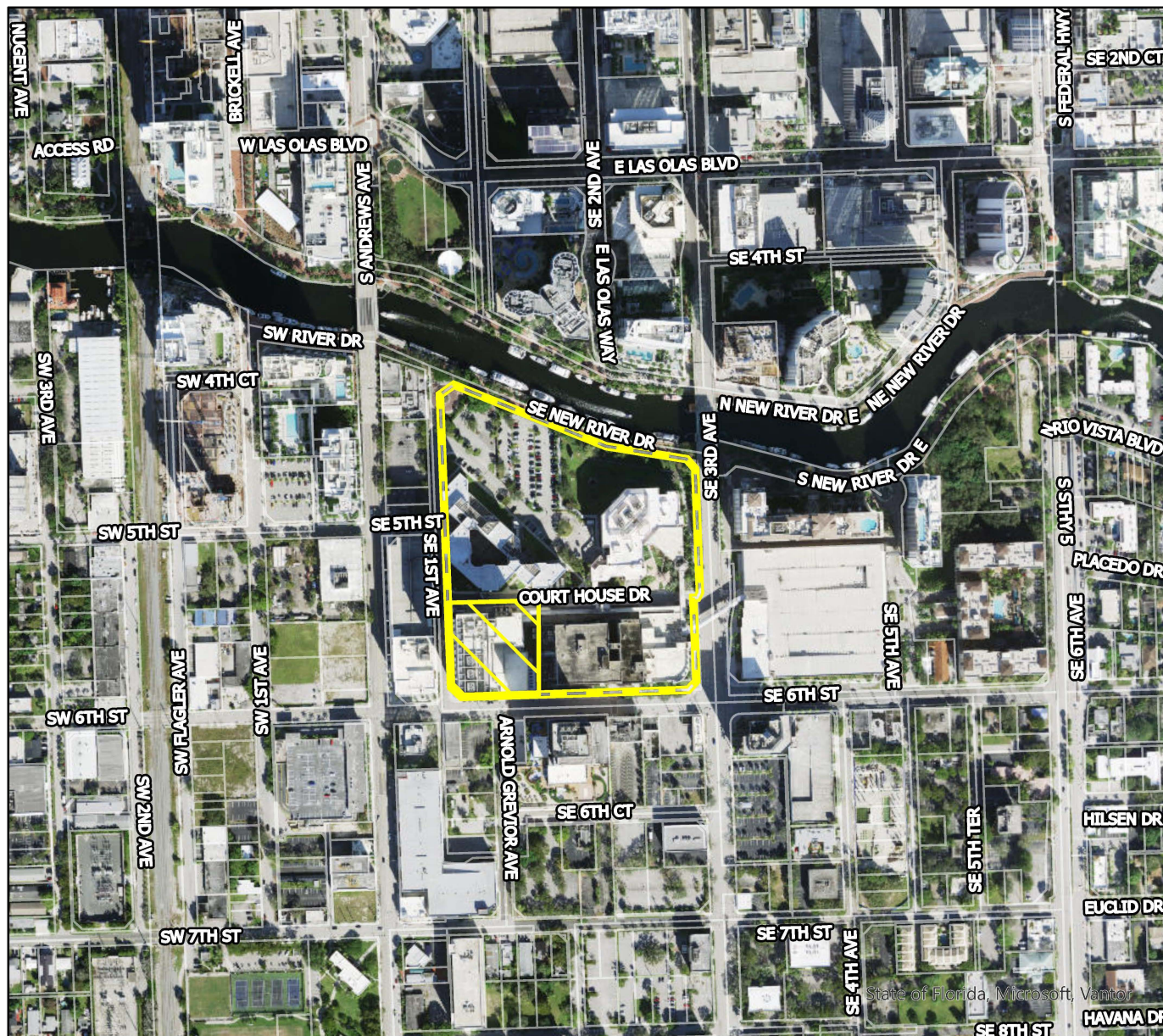

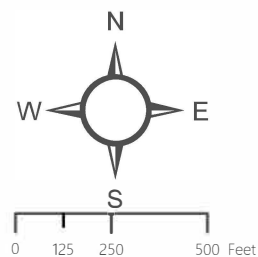


26-NM3: Greenhawt Courtroom Aerial Map

The subject property is a County facility within the City of Fort Lauderdale. Fort Lauderdale is a 'Certified Local Government,' outside of County historic preservation jurisdiction.

The application proposes to name an existing Family Division courtroom in honor of Judge Susan Greenhawt, a cherished judge who served the County's Family Division for decades. The existing County courthouse building dates to 2017. Earlier County courthouses and annexes on the site (1915, 1928, 1949, 1962) have all been removed.

A review of County site file information has determined that there are no historical or archaeological sites of concern within the subject property. Therefore, the proposal will have "no effect" on historical or archaeological resources and is cleared of historic preservation concerns.
