Pursuant to Section 1-81.3(f) of the Broward County Business Opportunity Act (the "Act"), as amended, when a CBE reserve is established in connection with a County solicitation, CBEs and non-CBEs may respond to the solicitation.

At the time that the CBE Reserve goal for this solicitation was established, due to the nature of this procurement and the lack of subcontracting opportunity, OESBD recommended that the twenty-five percent (25%) CBE goal be waived if a non-CBE bidder is considered for award.
