## RESOLUTION NO.

1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD  
2 COUNTY, FLORIDA, RELATING TO ECONOMIC DEVELOPMENT; APPROVING  
3 PROJECT ORANGE BLOSSOM FOR ECONOMIC DEVELOPMENT INCENTIVES  
4 PURSUANT TO SECTION 9½-52, BROWARD COUNTY CODE OF ORDINANCES;  
5 PROVIDING A TOTAL APPROPRIATION OF THREE HUNDRED TEN THOUSAND  
6 DOLLARS (\$310,000), INCLUDING A STRATEGIC JOB CREATION INCENTIVE IN THE  
7 AMOUNT OF TWO HUNDRED TEN THOUSAND DOLLARS (\$210,000) AND A DIRECT  
8 CASH/JOB CREATION INCENTIVE IN THE AMOUNT OF ONE HUNDRED THOUSAND  
9 DOLLARS (\$100,000), FOR FISCAL YEARS 2027 THROUGH 2036; AND PROVIDING  
10 FOR SEVERABILITY AND AN EFFECTIVE DATE.

12 WHEREAS, the corporation referred to as Project Orange Blossom for the purpose  
13 of this Resolution, has requested that Broward County maintain the confidentiality of its  
14 name and business information pursuant to Section 288.075, Florida Statutes;

15 WHEREAS, Project Orange Blossom, a Connecticut-based company specializing  
16 in global contract logistics, outsourced supply chains, and warehousing, is considering  
17 locating a global headquarters in the City of Fort Lauderdale, Florida; and

18 WHEREAS, Project Orange Blossom is requesting a Strategic Job Creation  
19 Incentive and a Direct Cash/Job Creation Incentive from Broward County pursuant to  
20 Section 9½-52, Broward County Code of Ordinances, NOW, THEREFORE,

21 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
22 BROWARD COUNTY, FLORIDA:

23           Section 1.    The Broward County Board of County Commissioners (“Board”)  
24 hereby approves economic development incentives for fiscal years 2027 through 2036,  
25 collectively, in a total aggregate amount not to exceed Three Hundred Ten Thousand  
26 Dollars (\$310,000), consisting of: (a) a Strategic Job Creation Incentive not to exceed a  
27 total amount of Two Hundred Ten Thousand Dollars (\$210,000), calculated on the basis  
28 of One Thousand Four Hundred Dollars (\$1,400) per qualifying job; and (b) a Direct  
29 Cash/Job Creation Incentive not to exceed a total amount of One Hundred Thousand  
30 Dollars (\$100,000), calculated on the basis of Six Hundred Sixty-Six Dollars and  
31 Sixty-Seven Cents (\$666.67) per qualifying job.

32           Section 2.    In furtherance of Project Orange Blossom’s request for approval, the  
33 Board has determined that the project’s private sector wage commitment shall be greater  
34 than two hundred percent (200%) of the average annual private sector wage in Broward  
35 County.

36           Section 3.    The amounts authorized herein shall constitute Broward County’s  
37 total commitment to this project for participation in the Strategic Job Creation Incentive  
38 Program and the Direct Cash/Job Creation Incentive Program.

39           Section 4.    The County Administrator is authorized to execute all necessary  
40 documents in connection with the award of the incentive, subject to review and approval  
41 for legal sufficiency by the County Attorney’s Office, provided the County’s total financial  
42 commitment does not exceed the maximum amounts stated herein.

43           Section 5.    The County Administrator is authorized to take all necessary  
44 administrative and budgetary actions to implement and administer the incentive award.
