SOLE SOURCE/SOLE BRAND REQUEST

I. REQUEST: Provide a description of the features of the product/service or Scope of Work.

Master Agreement #R0948502P1_1 with our current e-learning platform Percipio (Skillsoft Corporation), initially entered Nov 17, 2011, is a five year contract, with two one year extensions, was executed in November 2016 and ends on November 30, 2023. The contract was initially awarded via an RFP in 2011 and awarded Sole Source/Most Reasonable Source in 2016. We are seeking to renew our contract with them for five more years. Skillsoft's immersive learning platform, Percipio, inspires, motivates and engages learners, anytime, anywhere, on any device through interactive videos, simulations, and courses. 7,000+ courses. 24/7 cloud access. 180,000+ tools. 29 languages. 120,000 pieces of content. No other company offers equal depth and breadth of products accompanied by reliable customer support and personalized service. Broward County has a dedicated Customer Service Consultant available to us during business hours who engages with LOD to set objectives; curates solutions to meet our needs; enables adoption; and, reports on the values and impact to the County. Skillport Corporation also provides technical services 24/7. Over the past twelve plus years we have deeply integrated Percipio content into our Broward County training calendar, leadership programs, learning paths and employee development resources. We are currently mapping the new County Values and Core Competencies to related learning content thus further embedding Percipio in our HR processes. Percipio is integrated with our PeopleSoft Learning Management System (Learning Center) where we capture all learning activities for employees' learning transcripts and county performance measures. Percipio is accessed by employees on a dedicated 'tile' on the browardemployee.org Learning Center. [Attached a detailed Skillsoft product overview]

Operational Compatibility - replacement parts from alternate suppliers are not interchangeable with original part and causes equipment incompatibility. Previous findings and/or documentation is included with this request.

- Ease of Maintenance - maintenance or retooling prohibits competition. Section III, Comparative Market Research includes estimated costs associated with changing current source and/or brand.
- Follow-On - potential for continued development or enhancement with same supplier and eliminates costs incurred by using different supplier. Section III, Comparative Market Research includes estimated costs for replacing current or existing system.

Exempted from the Procurement Code – per Section 21.5 of Broward County Administrative Code.

- Other/or additional information – using this sole source, sole brand purchase benefits the County for the following reasons:

Skillport is deeply embedded into our Training Calendar and Management Development Programs (JumpStart, Leadership Round-table, Management Development Kit, Learning Paths, Certification Curriculum, etc ...) and referenced on browardemployee.org on every learning page. Over 20 years' worth of extensive user training has fostered an environment of understanding and comfort in terms of ease of use for employees at all levels of County employment. Percipio is securely integrated with our PeopleSoft learning management system. Replacing the existing (Percipio) platform would be costly in terms of man-hours needed to re-develop & re-train around a new eLearning system. An Internet search of alternate eLearning solutions has not provided a positive result in finding a comparable provider to Skillsoft/Percipio.

The financial impact of changing eLearning provider would be significant. Due to the integration of Percipio content in many of our Broward County specific employee and leadership development programs, we would incur the cost of recreating/building custom learning programs; historical data transfer and data migration fees; service charges; and delivery platform change over. Change over costs are estimated at \$165,500. The value and return on investment in Percipio for FY21 and FY22 based on course utilization and 'read time' for books equals over \$332,000 in comparable costs of training, certifications and books. Benefit to cost ratio demonstrates that for every \$1.00 invested in Skillsoft, \$18.00 of benefits are realized. [see attached Cost Benefit document].
Moving to an enterprise license would allow access to all employees for mandatory training such as Safety, Compliance, Cyber-Security, and Employment Policies – the cost of an enterprise license would be offset by these county-wide mandatory trainings as they are currently paid for separately. Risk Management are planning to engage project management as Optional Services for the volume of compliance training projected.

Additional Information:

A Request for Information (RFI) No. R0948502F1 was issued on April 3, 2023, to determine if other vendors were able to provide the requested services. The RFI closed on April 10, 2023, with two responses submitted. A total of 5,935 vendors were successfully invited. There were 25 views, and no vendor questions were asked. The Contract Administrator reviewed the two submissions submitted and determined that none meet the Agency's needs for an elearning Platform and Services. Skillsoft's immersive learning platform, Percipio, from Skillsoft Corporation was identified as the Sole Source product to meet Broward County requirements. Per the Broward County procurement Code, Section 21.25, Sole Source procurement and 21.26, Sole Brand Procurement, Section (b), the purchasing Agent affirms that this request is the subject of an RFI, the required due diligence has been completed, and therefore recommends approval of this Sole Source/ Most Reasonable Source request.
