AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO CERTAIN MEMBERSHIP, MEETING, DUTY, AND APPOINTMENT REQUIREMENTS FOR VARIOUS COMMITTEES AND BOARDS; AMENDING SECTIONS 1-340, 1-384, AND 5-535 OF THE BROWARD COUNTY CODE OF ORDINANCES ("CODE"); REPEALING ARTICLE XXXII OF CHAPTER 1, ARTICLE III OF CHAPTER 18 AND SECTIONS 18-33 THROUGH 18-51, AND ARTICLE III OF CHAPTER 30 OF THE CODE, AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE.

(Sponsored by the Board of County Commissioners)

WHEREAS, Section 2.09 of the Broward County Charter and Sections 1-244 through 1-247 of the Broward County Code of Ordinances provide for the periodic review of all existing Broward County boards, authorities, and agencies; and

WHEREAS, the Board of County Commissioners of Broward County, Florida, has completed this review and determined that certain amendments are appropriate at this time,

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. Section 1-340 of the Broward County Code of Ordinances, pertaining to the Nancy J. Cotterman Center Trust Fund Committee, is hereby amended to read as follows:

Section 3. Section 5-535 of the Broward County Code of Ordinances, pertaining to the Historic Preservation Board, is hereby amended to read as follows:

## Sec. 5-535. Historic Preservation Board.

(b) The Historic Preservation Board shall be comprised composed of nine (9) members, each of whom shall be appointed by the County Commission. All members of the Historic Preservation Board shall be residents of Broward County and shall possess demonstrated knowledge, experience, and commitment to historic preservation. Each County Commissioner shall nominate one (1) member to the Historic Preservation Board. One (1) member of the Historic Preservation Board shall be a licensed architect with demonstrable historic preservation experience. The remaining eight (8) members shall be practicing or retired professionals from each at least one (1) of the following areas of disciplines:

- (7) General or building contractor; and
- (8) Professional engineering-; and
- (9) Teaching a subject area as described in (1) to (8) above.

In the event no qualified individual has expressed interest in serving in a specific category one of the categories as listed in (1) to (9) above, a Commissioner may nominate an individual with demonstrated special interest, experience, or knowledge of history,

architecture, or related disciplines to ensure a Historic Preservation Board <del>comprised</del> composed of subject matter professionals in the field of historic preservation.

Section 4. Article XXXII of Chapter 1 of the Broward County Code of Ordinances, pertaining to the North District Regional Wastewater Advisory Board, is hereby repealed in its entirety.

Section 5. Article III of Chapter 18 and Sections 18-33 through 18-51 of the Broward County Code of Ordinances, pertaining to the Broward County Narcotics and Dangerous Drug Intelligence and Enforcement Unit, are hereby repealed in their entirety.

Section 6. Article III of Chapter 30 of the Broward County Code of Ordinances, pertaining to the Broward County Erosion Prevention District, is hereby repealed in its entirety.

## Section 7. Severability.

If any portion of this Ordinance is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Ordinance. If any court determines that this Ordinance, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Ordinance to any other individual, group, entity, property, or circumstance.

Section 8. Inclusion in the Broward County Code of Ordinances.

It is the intention of the Board of County Commissioners that the provisions of this Ordinance become part of the Broward County Code of Ordinances as of the effective date. The sections of this Ordinance may be renumbered or relettered and the word

"ordinance" may be changed to "section," "article," or such other appropriate word orphrase to the extent necessary to accomplish such intention.

Section 9. Effective Date.

This Ordinance is effective as of the date provided by law.
