1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, PERTAINING TO THE BROWARD ADDICTION RECOVERY
3 DIVISION; AMENDING CHAPTERS 2, 4, 12, 23, AND 36 OF THE BROWARD COUNTY
4 ADMINISTRATIVE CODE ("ADMINISTRATIVE CODE") TO UPDATE THE NAME OF
5 THE BROWARD ADDICTION RECOVERY DIVISION; AND PROVIDING FOR
6 SEVERABILITY, INCLUSION IN THE ADMINISTRATIVE CODE, AND AN EFFECTIVE
7 DATE.

9 WHEREAS, Broward Addiction Recovery Division (BARD) is the division's formal
10 name, but its informal name, Broward Addiction Recovery Center (BARC), has been
11 widely used by County staff and the community for over 50 years. Officially renaming the
12 division to the Broward Addiction Recovery Center will provide clarity and ensure
13 consistency in how the agency is recognized and referenced; and

14 WHEREAS, the Board of County Commissioners desires to update the Broward
15 County Administrative Code to officially reflect the division's name as the Broward
16 Addiction Recovery Center, NOW, THEREFORE,

17 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
18 BROWARD COUNTY, FLORIDA:

19 Section 1. Chapters 2, 4, 12, 23, and 36 of the Broward County Administrative
20 Code are hereby amended to replace each instance of "Broward Addiction Recovery
21 Division" throughout each chapter with "Broward Addiction Recovery Center."

22 Section 2. Chapter 4, Part IV, Section 4.30 of the Broward County
23 Administrative Code is hereby amended to replace each instance of "Division" throughout
24 with "Center."

25 Section 3. Severability.

26 If any portion of this Administrative Code Resolution is determined by any court to
27 be invalid, the invalid portion will be stricken, and such striking will not affect the validity
28 of the remainder of this Administrative Code Resolution. If any court determines that this
29 Administrative Code Resolution, in whole or in part, cannot be legally applied to any
30 individual, group, entity, property, or circumstance, such determination will not affect the
31 applicability of this Administrative Code Resolution to any other individual, group, entity,
32 property, or circumstance.

33 Section 4. Inclusion in the Broward County Administrative Code.

34 It is the intention of the Board of County Commissioners that the provisions of this
35 Administrative Code Resolution become part of the Broward County Administrative Code
36 as of the effective date. The sections of this Administrative Code Resolution may be
37 renumbered or relettered and the word "resolution" may be changed to "section," "article,"
38 or such other appropriate word or phrase to the extent necessary to accomplish such
39 intention.

40 Section 5. Effective Date.

41 This Administrative Code Resolution is effective upon adoption.
