RE: Broward County Taximeter Rates

The Consumer Protection Division (CPD) last completed its bi-annual review of taximeter rates in February of 2022, pursuant to Section 22½-11(c)(1), and determined that an increase was not warranted, given then current market rates, Consumer Price Index trends, an unrelated pending temporary increase to the drop rate due to gasoline prices, and a recently enacted waiver of permit fees. More recently, the Division received requests from the industry regarding an increase to taximeter rates, in light of continuing economic and neighboring market changes.

Broward County taximeter rates last increased in October of 2018. Since then, the Consumer Price Index ("CPI") in South Florida has increased 35%, while gas prices have increased by 20%. Transportation network companies ("TNC") rates for off-peak hours are slightly above Broward County's current taximeter rates; however, surge pricing can increase TNC rates to more than 48% higher than taxi rates.

Current rates for a five (5) mile trip in Broward County yield a \$14.55 fare; whereas in Miami Dade County (subsequent to the mid-2022 rate increase) a comparable trip yields a \$20.40 fare; a five (5) mile trip from Palm Beach International Airport yields \$15.37 (note: PBC does not regulate taxi fees outside of the airport). Based on review of 18 comparable jurisdictions, including Miami Dade County and Palm Beach International Airport, seventy-nine (79) percent have a higher taximeter rate than Broward County (see 2023 Taxi Rate Survey).

The following table depicts various scenarios for a potential Broward County increase to the 1/6 of a mile rate (currently \$0.40), while leaving the current drop rate (\$2.95 for first 1/6 mile) constant:
