RESOLUTION NO.

1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, AUTHORIZING APPROPRIATION AND DISBURSEMENT OF
3 RYAN WHITE PROGRAM FUNDS TO SPECIFIED SERVICE PROVIDERS IN THE
4 ESTIMATED AGGREGATE AMOUNT OF \$19,946,634 FOR RYAN WHITE FISCAL
5 YEAR 2026-2027; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ALL
6 NECESSARY ADMINISTRATIVE AND BUDGETARY ACTIONS TO IMPLEMENT THE
7 AGREEMENTS; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

9 WHEREAS, the U.S. Department of Health and Human Services, Health
10 Resources and Services Administration (“HRSA”) annually awards funds to Broward
11 County for the provision of Ryan White Part A (“RW”) core medical and support services,
12 Minority AIDS Initiative (“MAI”) services, planning and evaluation services, and Ending
13 the HIV Epidemic in the US (“EHE”) program services (collectively, the “Services”);

14 WHEREAS, on September 5, 2024, the Board of County Commissioners of
15 Broward County, Florida (“Board”), approved the HRSA RW grant application for the
16 award period commencing on March 1, 2025, and ending on February 29, 2028;

17 WHEREAS, on October 8, 2024, the Board approved the HRSA EHE grant
18 application for the award period commencing on March 1, 2025, and ending on
19 February 28, 2030;

20 WHEREAS, the Board anticipates an award of HRSA funds for Ryan White Fiscal
21 Year 2026-2027 ("FY2027") and expects payment of funds (in part) from HRSA for
22 Services by March 1, 2026;

23 WHEREAS, the Board desires to renew existing agreements with specified
24 service providers (previously approved by the Board in Resolution No. 2025-032 on
25 February 25, 2025, Item No. 5) for FY2027 to continue the provision of Services; and

26 WHEREAS, the Board finds that the Services to be funded benefit the residents
27 of Broward County and serve a public purpose, NOW, THEREFORE,

28 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
29 BROWARD COUNTY, FLORIDA:

30 Section 1. The Board hereby authorizes appropriation and disbursement of
31 funds in the estimated aggregate amount of Nineteen Million Nine Hundred Forty-six
32 Thousand Six Hundred Thirty-four Dollars (\$19,946,634) for FY2027, as specified in
33 Attachments A and B.

34 Section 2. Upon receipt of the grant award from HRSA, the service providers'
35 agreements identified in Attachments A and B will be renewed for FY2027 in accordance
36 with the terms and conditions of the agreements. The County Administrator is hereby
37 authorized to take all necessary administrative and budgetary actions to implement the
38 renewed agreements.

39 Section 3. Severability.

40 If any portion of this Resolution is determined by any court to be invalid, the invalid
41 portion will be stricken, and such striking will not affect the validity of the remainder of this
42 Resolution. If any court determines that this Resolution, in whole or in part, cannot be

43 legally applied to any individual, group, entity, property, or circumstance, such
44 determination will not affect the applicability of this Resolution to any other individual,
45 group, entity, property, or circumstance.

46 | Section 4. Effective Date.

47 This Resolution is effective upon adoption.
