A RESOLUTION OF THE PERFORMING ARTS CENTER AUTHORITY, AN INDEPENDENT SPECIAL DISTRICT IN THE STATE OF FLORIDA; ADOPTING ITS FINAL OPERATING BUDGET FOR FISCAL YEAR 2025 FOR THE PERIOD COMMENCING OCTOBER 1, 2024, THROUGH SEPTEMBER 30, 2025; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, a copy of the budget is either attached to the Resolution or simultaneously accompanies the Resolution on the Board's agenda, NOW, THEREFORE,

BE IT RESOLVED BY THE PERFORMING ARTS CENTER AUTHORITY:

Section 1. <u>ADOPTION</u>.

The Board adopts PACA's operating budget for Fiscal Year 2025 which commences on October 1, 2024, through September 30, 2025. The adopted budget is subject to approval of the Broward County's Commission and Fort Lauderdale's City
