ORDINANCE NO.

1 AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, PERTAINING TO MANDATORY COURT COSTS; AMENDING
3 SECTION 10-5 OF THE BROWARD COUNTY CODE OF ORDINANCES (“CODE”); AND
4 PROVIDING FOR SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE
5 DATE.

6 (Sponsored by the Board of County Commissioners)

8 WHEREAS, Section 938.19, Florida Statutes, authorizes the Broward County
9 Board of County Commissioners (the “Board”) to impose a local assessment of up to
10 Three Dollars (\$3.00) for certain offenses, including violations of criminal law, local
11 ordinances, and uniform traffic laws, to fund the operation and administration of teen
12 courts in Broward County (“Mandatory Court Costs”);

13 WHEREAS, Section 10-5 of the Broward County Code of Ordinances (“Code”) ~~establishes~~
14 establishes an assessment of Mandatory Court Costs in the amount of Two Dollars
15 (\$2.00); and

16 WHEREAS, the Board finds that it is in the best interest of the County to amend
17 Section 10-5 of the Code to increase the current assessment of Mandatory Court Costs
18 from Two Dollars (\$2.00) to Three Dollars (\$3.00),

19 BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
20 BROWARD COUNTY, FLORIDA:

21 Section 1. Section 10-5 of the Broward County Code of Ordinances is hereby
22 amended to read as follows:

23 **Sec. 10-5. Assessment of additional court costs for the operation and support of**
24 **the teen court.**

26 (b) A sum of ~~Two~~ Three Dollars (~~\$2.00~~) (\$3.00) shall be assessed as a court
27 cost in the Circuit and County Court in Broward County against each person (i) who is
28 convicted of, or pleads guilty or nolo contendere (no contest) to, violation of a criminal
29 law, a delinquent act, or a municipal or county ordinance, regardless of whether
30 adjudication, is withheld; (ii) who pays a fine or civil penalty for any violation of
31 Chapter 316, Florida Statutes, the Florida Uniform Traffic Control Law; or (iii) who is
32 adjudicated delinquent. Any person whose adjudication is withheld under
33 Section 318.14(9) or Section 318.14(10), Florida Statutes, shall also be assessed the
34 cost.

35 . . .

36 Section 2. Severability.

37 If any portion of this Ordinance is determined by any court to be invalid, the invalid
38 portion will be stricken, and such striking will not affect the validity of the remainder of this
39 Ordinance. If any court determines that this Ordinance, in whole or in part, cannot be
40 legally applied to any individual, group, entity, property, or circumstance, such
41 determination will not affect the applicability of this Ordinance to any other individual,
42 group, entity, property, or circumstance.

43 Section 3. Inclusion in the Broward County Code of Ordinances.

44 It is the intention of the Board of County Commissioners that the provisions of this
45 Ordinance become part of the Broward County Code of Ordinances as of the effective
46 date. The sections of this Ordinance may be renumbered or relettered and the word
47 "ordinance" may be changed to "section," "article," or such other appropriate word or
48 phrase to the extent necessary to accomplish such intention.

49 Section 4. Effective Date.

50 This Ordinance is effective as of the date provided by law.
