SECOND AMENDMENT TO AGREEMENT BETWEEN BROWARD COUNTY AND LEGAL AID SERVICE OF BROWARD COUNTY, INC. FOR LEGAL ASSISTANCE FOR ECONOMIC STABILITY

Agreement #: 22-FSAD-8309-1

This Second Amendment ("Amendment") is entered into between Broward County, a political subdivision of the State of Florida ("County"), and Legal Aid Service of Broward County, Inc., an active Florida nonprofit corporation ("Provider"), each a "Party" and collectively referred to as the "Parties."

RECITALS

- A. The Parties entered into the original Agreement on April 4, 2022, for legal assistance for economic stability ("Agreement").
- B. On February 11, 2025, the Parties executed a First Amendment to the Agreement to (i) add a third Option Period; (ii) update the contact information for official notifications to County and County's Custodian of Public Records; and (iii) add requirements for Ownership Disclosure, Entities of Foreign Concern, and Anti-Human Trafficking.
- C. The Parties are currently in Option Period 3 and now desire to amend the Agreement to (i) add a fourth Option Period, (ii) update County's Custodian of Public Records, and (iii) update Exhibits A and D-1.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- 1. The above Recitals are true and correct and are incorporated herein by reference. All capitalized terms not expressly defined within this Amendment will retain the meaning ascribed to such terms in the Agreement.
- Unless otherwise expressly stated herein, amendments to the Agreement made under this Amendment are indicated herein by use of strikethroughs to indicate deletions and underlining to indicate additions. Except as modified herein, all remaining terms and conditions of the Agreement remain in full force and effect.
- 3. The Agreement is hereby amended to add one (1) Option Period that will begin on October 1, 2025, and continue through September 30, 2026 ("Option Period 4").
- 4. The last paragraph of Section 15.2 of the Agreement is amended as follows:
 - IF PROVIDER HAS QUESTIONS REGARDING THE APPLICATION OF CHAPTER 119, FLORIDA STATUTES, TO PROVIDER'S DUTY TO PROVIDE PUBLIC RECORDS RELATING TO THIS AGREEMENT, CONTACT THE

- 7. Exhibit D-1, Section I.E.2, of the Agreement is amended as follows:
 - 2. Legal Services Intake:
 - a. Cost per Unit of Service: \$45.00
 - b. Definition: One (1) hour of <u>Client</u> intake coverage by a paralegal.
 - c. Required Staff Credentials and Licensure: Provider must ensure all paralegals providing services under this Agreement have completed formal paralegal education or have a minimum of one (1) year experience as a paralegal under the supervision of a licensed attorney.
- 8. Exhibit D-1, Section II, of the Agreement is replaced in its entirety with the following:
 - II. Maximum Number of Units to be Purchased Annually:
 - A. 1st service (Legal Services): Up to 456 units
 - B. 2nd service (Legal Intake): Up to 780 units

Units per Extension, if exercised: Must be equal to a pro rata number of units of the then-current annual units per service

- 9. In the event of any conflict or ambiguity between this Amendment and the Agreement, the Parties agree that this Amendment will control. The Agreement, as amended herein by this Amendment, incorporates and includes all prior negotiations, correspondence, conversations, agreements, and understandings applicable to the matters contained herein, and the Parties agree that there are no commitments, agreements, or understandings concerning the subject matter hereof that are not contained in the Agreement as amended in this Amendment. Accordingly, the Parties agree that no deviation from the terms hereof will be predicated upon any prior representations or agreements, whether oral or written.
- 10. Preparation of this Amendment has been a joint effort of the Parties, and the resulting document will not, solely as a matter of judicial construction, be construed more severely against one of the Parties than any other.
- 11. Provider acknowledges that through the date this Amendment is executed by Provider, Provider has no claims or disputes against County with respect to any of the matters covered by the Agreement.
- 12. This Amendment is effective October 1, 2025.
- 13. This Amendment may be executed in multiple originals or in counterparts, whether signed physically or electronically; each of which will be deemed to be an original, and all of which, taken together, will constitute one and the same agreement.
