

Seven established Private Tag Agencies (PTAs) have contracts with Broward County to provide PTA services. The locations are Fort Lauderdale, Lauderhill, Deerfield, Coral Springs, Pembroke Pines, Hollywood, and Weston. The summary below provides a brief chronology of the agencies.

On September 24, 1996 (Item No. 94), the Board approved a Request for Letters of Interest (RLI) #032096-RB, establishing a Selection/Negotiation Committee (S/NC) to recommend the most highly qualified firms to provide PTA services in the County. Five PTAs were approved at this time and opened on various dates from 1997-2000.

On August 22, 2006 (Item No. 11), the Board approved the Amendment that extended the termination date for existing PTAs to September 30, 2008.

On September 9, 2008 (Item No. 9), the Board approved contract extensions for the current five PTAs with a termination date of September 30, 2009.

On January 6, 2009 (Item No. 4), the Board approved the Agreements with South Broward Tag Agency, LLC for PTA services in the Southeastern Hollywood and Weston locations. The contracts were for a three-year term with two one-year renewals and commenced on July 1, 2009.

On June 9, 2009 (Item No. 64), the Board approved contract extensions for the five existing PTAs, allowing for a one-year term from the current termination date of September 30, 2009, and allowing for renewal of up to four consecutive one-year terms.

On June 4, 2013 (Item No. 72), the Board approved contract extensions for the South Broward Tag Agency, LLC for PTA services in the Southeastern Hollywood and Weston locations with a termination date of September 30, 2015, to coincide with the expiration date for the other five PTAs.

On September 10, 2015 (Item No. 13), the Board approved contract extensions for all PTAs for a one-year term with four one-year renewals. This extended the contract expiration date for all contracts until September 30, 2020.

On August 22, 2017 (Item No. 59), the Board approved an adjustment to the PTA fee schedule. This was the first fee adjustment for the PTAs since 1997 and was commensurate with the Consumer Price Index adjustments for the period.

On September 24, 2019 (Item No. 26), the Board approved amendments to the PTA agreements, which extended the agreement expiration dates from September 30, 2019, until January 7, 2025. ("Extended Renewal Period"). The amendments also provided for an assignment of the agreements to an elected Broward County Tax Collector and for an additional optional five-year extension beyond the Extended Renewal Period.

On March 31, 2020 (Item No. 28), the Board approved amendments to the PTA agreements, which included customer transaction fee increases, as follows: registration renewals from \$3.50 to \$3.85, Fast Titles from \$20 to \$25 and Title Applications for Original or Transfer Certificate of Title from \$15 to \$16.50. Additional language was included to allow the County's review and revision of Fast Title fees if needed, to further define "Commercial Accounts" and to limit the increase to customer transaction fees for the duration of the remaining term of the agreements.

On April 6, 2021 (Item No. 37), the Board approved amendments to the PTA agreements, which allowed the PTAs to accept payment card transactions and modified their insurance and bond requirements.
