## RESOLUTION NO.

1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD  
2 COUNTY, FLORIDA, ACCEPTING A CASH DONATION OF TWELVE THOUSAND  
3 NINE HUNDRED FIFTY DOLLARS (\$12,950) FROM BROWARD PUBLIC LIBRARY  
4 FOUNDATION, INC., TO PROVIDE SCHOLARSHIPS FOR TEN ELIGIBLE BROWARD  
5 COUNTY RESIDENTS SEEKING TO OBTAIN THEIR HIGH SCHOOL DIPLOMAS;  
6 AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ALL NECESSARY  
7 ADMINISTRATIVE AND BUDGETARY ACTIONS TO ACCEPT THE DONATION; AND  
8 PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

10 WHEREAS, Broward Public Library Foundation, Inc. ("Foundation"), has  
11 generously offered to donate Twelve Thousand Nine Hundred Fifty Dollars (\$12,950) to  
12 the Broward County Libraries Division to provide scholarships for ten eligible Broward  
13 County residents seeking to obtain their high school diplomas;

14 WHEREAS, the donated funds will be deposited into the Broward County Library  
15 Trust Fund within the General Trust Fund (Program Code 95501);

16 WHEREAS, Section 18.63 of the Broward County Administrative Code requires  
17 that donations to Broward County valued at Ten Thousand Dollars (\$10,000) or more be  
18 accepted by a resolution of the Board of County Commissioners (the "Board"), describing  
19 the name and address of the donor, the amount of the donation, the specific purposes for  
20 which the donation is made, any restriction on the use of the donation, and the applicable  
21 account into which the donation shall be placed pending expenditure; and

22 WHEREAS the Board wishes to accept this generous donation and to express its  
23 gratitude, NOW, THEREFORE,

24 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
25 BROWARD COUNTY, FLORIDA:

26 Section 1. The Board hereby accepts a donation of Twelve Thousand Nine  
27 Hundred Fifty Dollars (\$12,950) from Broward Public Library Foundation, Inc., located at  
28 100 S. Andrews Avenue, Fort Lauderdale, Florida 33301. This amount will be deposited  
29 into the Broward County Library Trust Fund, which is part of the General Trust Fund  
30 (Program Code 95501).

31 Section 2. The County Administrator is hereby authorized to take all  
32 administrative and budgetary actions and to execute all forms required to implement  
33 acceptance of the donation and expenditure in accordance with the purposes stated in  
34 this Resolution.

35 Section 3. Severability.

36 If any portion of this Resolution is determined by any court to be invalid, the invalid  
37 portion will be stricken, and such striking will not affect the validity of the remainder of this  
38 Resolution. If any court determines that this Resolution, in whole or in part, cannot be  
39 legally applied to any individual, group, entity, property, or circumstance, such  
40 determination will not affect the applicability of this Resolution to any other individual,  
41 group, entity, property, or circumstance.
