AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO THE TREE PRESERVATION TRUST FUND AND THE REORGANIZATION OF THE PUBLIC WORKS AND ENVIRONMENTAL SERVICES DEPARTMENT ("PWESD") AND THE HOUSING AND URBAN PLANNING DIVISION ("HUPD"); AMENDING CHAPTERS 1, 5, 8½, 9½, 14, 21, 27, 34, AND 39 OF THE BROWARD COUNTY CODE OF ORDINANCES ("CODE") TO REFLECT THE ORGANIZATIONAL CHANGES MADE TO THE PWESD AND THE HUPD; AMENDING SECTION 27-413 OF THE CODE TO REVISE PROVISIONS RELATED TO TRUST EXPENDITURES; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Broward County, Florida ("Board"), adopted that certain Resolution reorganizing the Public Works Department ("PWD") and the Resilient Environment Department ("RED") as the Public Works and Environmental Services Department ("Resolution") within the Broward County Administrative Code ("Administrative Code");

WHEREAS, the Resolution further amended the Administrative Code to reorganize the Housing Finance Division ("HFD") and the Urban Planning Division ("UPD") as the Housing and Urban Planning Division;

28	Section 1. Chapters 1, 5, 8½, 9½, 21, 27, 34, and 39 of the Broward County

Section 1. Chapters 1, 5, 8½, 9½, 21, 27, 34, and 39 of the Broward County Code of Ordinances are hereby amended to replace each instance of "Resilient Environment Department" throughout each chapter with "Public Works and Environmental Services Department," and each instance of "RED" throughout each chapter with "PWESD."

Section 2. Chapters 8½, 9½, and 14 of the Broward County Code of Ordinances are hereby amended to replace each instance of "Public Works Department" throughout each chapter with "Public Works and Environmental Services Department."

Section 3. Chapters 5 and 39 of the Broward County Code of Ordinances are hereby amended to replace each instance of "Urban Planning Division" throughout each chapter with "Housing and Urban Planning Division," and each instance of "UPD" throughout each chapter with "HUPD."

Section 4. Chapters 5 and 27 of the Broward County Code of Ordinances are hereby amended to replace each instance of "Housing Finance Division" throughout each chapter with "Housing and Urban Planning Division."

Section 6. Severability.

If any portion of this Ordinance is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Ordinance. If any court determines that this Ordinance, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Ordinance to any other individual, group, entity, property, or circumstance.

Section 7. Inclusion in the Broward County Code of Ordinances.

It is the intention of the Board of County Commissioners that the provisions of this Ordinance become part of the Broward County Code of Ordinances as of the effective date. The sections of this Ordinance may be renumbered or relettered and the word "ordinance" may be changed to "section," "article," or such other appropriate word or phrase to the extent necessary to accomplish such intention.

Section 8. Effective Date.

This Ordinance is effective as of the date provided by law.
