As a follow up to our conversation last week, Commissioner Bogen had some language drafted related to his interest in proposing an ordinance related to a disclosure related to calcium score tests.

He asked that I share the below wording for the ordinance he would be proposing with you to see if this is something you would be comfortable with/not oppose.

“Any facility, hospital or diagnostic center that offers a test referred to as a "Calcium Score" where no IV is used and no contrast is given to the patient, that facility, hospital or diagnostic center must inform the patient that such test does not test for soft plaque.”

Please let me know when you have a chance to review. As always, if you have any questions, call me, or Commissioner Bogen directly, as I’m sure he would be happy to walk you through his proposal.
