Compliance Comments:

In accordance with Title 49 CFR Part 26.39 (b) (2), Moss/Kiewit was required to "specify the elements of the contract, or specific subcontracts that are of a size that small businesses, including Disadvantaged Business Enterprises (DBEs), can reasonably perform." Additionally, its subcontractors had to meet the "small business" definition provided by the Small Business Administration (SBA) regulations in Title 13 CFR Part 121. On November 6, 2018, Moss/Kiewit submitted the specific subcontracts estimated at \$24,413,824.00, and the list of small businesses they were planning to use for the selected work. OESBD reviewed this information and confirmed that the proposed firms met the small business definition requirement, and that at least one of them was a DBE firm.

To date, Moss/Kiewit has paid \$24,184,622.76 to its small business subcontractors, which represents 7.23% of the construction costs subject to small business participation. Verification of these payments was conducted through an independent verification process, and confirmation was received from each subcontractor listed on Moss/Kiewit's Monthly Utilization Report (MUR) through February 29, 2024.

In summary, Moss & Associates, LLC, and Kiewit Infrastructure South Co. d/b/a Moss/Kiewit has attained 7.23% in small business participation and is in compliance with Title 49 of the Code of Federal Regulations (CFR) Part 26 and the element of Fostering Small Business Participation in accordance with Title 49 CFR Part 26.39 (b) (2).
