MBR Construction, Inc. (MBR) has three performance evaluations in Contracts Central for the previous three years.

MBR received an overall performance rating of 3.22 for the Construction of Sunview Park Community Center completed in 2019. However, MBR received five ratings of "2" (Poor) regarding site cleanliness, project superintendence, safety standards, and progress of the work. MBR no longer employs the site superintendent responsible for project superintendence and enforcing safety standards, and many of these issues were resolved before completion of the construction work.

The Parks Planning & Design Section of the Parks and Recreation Division recommends award to MBR for the following reasons:

- MBR has since completed two construction projects for the Parks and Recreation Division and received performance evaluations of at least 4.30, neither of which includes ratings of "2" or "1":
 - ✓ New Tree Tops South Restroom, completed in 2022 for approximately \$325,000
 - ✓ Everglades Holiday Park Site Improvements, completed in 2022 for approximately \$12,000,000
- References from other municipalities are all positive, as indicated in the attached Vendor Reference Verification Forms
- Parks is currently utilizing the services of MBR for other construction projects and although there is occasionally room for improvement, MBR performs well and collaborates with Parks staff to find solutions and complete projects on time and within budget
