damages, actions, suits, claims or demands of whatsoever kind made by or on behalf of any person as a result of SHERIFF selzing, retaining and/or returning possession of any of the above-described personal property to CLAIMANT, including, but not limited to, additional reasonable attorney's fees (in addition to the \$21,500.00 that is the subject of this agreement) and travel and investigative expenses caused by or related to such damages, actions, suits, claims or demands.

The Broward Sheriff's Office seized a total of \$171,460.00 in US Currency from multiple claimants, on September 16, 2022. After winning at the trial court, the claimant filed an appeal to the 4th DCA which overturned the trial's court decision. The 4th DCA mandate ordered the Broward Sheriff's Office to return \$171,460.00. Consequently, these funds were returned to The Estate of Jhourdan Hernandez on May 13, 2024.

A Motion for Attorney's fees was filed and BSO negotiated the payment to the claimant in anticipation of a negative ruling at the hearing set on September 29, 2025. A Settlement Agreement was executed, and an Agreed Order obtained from the court, instructing the Broward Sheriff's Office to pay the amount of \$21,500.00 to Rudenberg Law, P.A. fbo Jeischa Jane Aldana Perez. Please see attached Court Order signed by Hon. Judge Fabienne Fahnestock on October 30, 2025.
