CBE Compliance Comments:

Both Jarret Walker & Associates LLC and Nelson/Nygaard Consulting Associates have submitted Letters of Intent (LOIs) for each certified CBE firm they intend to use to fulfill the goal. Dudley's Professional Services did not initially provide the required LOIs, so they were contacted and given a three-day window to submit them. Unfortunately, Dudley's Professional Services failed to provide the requested documentation within the given time frame, and as a result, they were deemed non-compliant with the Office of Economic and Small Business Development's (OESBD) Small Business requirements.

However, the situation was later revised, and Dudley's Professional Services was included as compliant due to a 48-hour Director of Purchasing Memorandum that contained the vendor's LOIs. To sum it up, Jarret Walker & Associates LLC, Nelson/Nygaard Consulting Associates, and Dudley's Professional Services have all submitted the required LOIs for each certified CBE firm they plan to use to achieve the goal. As a result, all three vendors are compliant with OESBD's Small Business Requirements.
