CBE Compliance Evaluation for Change Order Allowance Increase

This memorandum supersedes the previous memorandum dated November 13, 2024

The Office of Economic and Small Business Development (OESBD) has conducted a review of Florida Palm Construction, Inc.'s CBE participation through October 31, 2024. The CBE goal for the project is 25% and Florida Palm committed to 25% CBE participation. An overview is provided as follows:

Compliance Comments:

Florida Palm Construction, Inc. has attained 100% CBE participation through October 31, 2024 and is in compliance with the CBE program requirements of this contract. Payment to the CBE firm was verified through an independent verification process.

Construction Management Division (CMD) reported that a motion will be submitted to the Board of County Commissioners to approve an increase in the change order allowance for Contract No. PNC2121515C1 between Florida Palm Construction, Inc. and Broward County.

Board of County Commissioners approval is required to increase the change order allowance above 10% of the original contract amount, in accordance with Broward County Procurement Code, Section 21.56.

This increase from \$287,559 to \$440,994, or 23% of the original contract amount of \$1,917,059, will allow to address redesign and reconfiguration of the fire alarm system by adding, relocating or removing approximately 130 separate fire alarm devices.
