  - CORPORATE SEAL if executing party is a corporation.
  - Please note: Request cannot be scheduled until the executed agreement is approved by the County Attorney.
- 2. Three (3) folded copies of a site plan drawn to scale, showing the following: Location of buildings, driveways with connection to dedicated rights-of-way, parking spaces and a legal description.
- 3. A check payable to the Broward County Board of County Commissioners for the applicable application fees based upon the published fee schedule.

Dear Karina:

Holland & Knight LLP is assisting Kiewit Water Facilities Florida CO ("Kiewit") in connection with the approval and development of the Prospect Lake Clean Water Center within the City of Fort Lauderdale. The Prospect Lake Clean Water Center ("PLCWC" or the "Facility") will replace the existing Five Ash Water Treatment plant currently serving the residents and businesses in the City of Fort Lauderdale (the "City") and will be capable of treating 50 million gallons of well water per day to provide potable water for the City. The Facility is an "essential government facility" as contemplated by Section 5-187 of the Broward County Code of Ordinances and Article 4.4(B) of the Administrative Rules Document: BrowardNext.

In connection with the development of the PLCWC, Kiewit is processing, on behalf of the City, an application to plat the property wherein the Facility will ultimately be located. The Prospect Lake Clean Water Center Plat (027-MP-23) has been filed with both the City and Broward County (the "County") to plat an area of property generally located west of N.W. 31st Avenue, east of U.S. 441 and north of Prospect Road. The Facility will consist of a series of structures and equipment and will include, but is not limited to, tanks, filters, pumps, an Administrative/Control/Warehouse building and a Nano Filtration Building.

In order to facilitate the permitting and construction of this essential government facility, the City and County have prepared the enclosed Agreement for the Issuance of Building Permits After Completed Plat Application for Essential Governmental Facilities consistent with Section 5-187 of the Code of Ordinances of the County and Article 4.4(B) of the Administrative Rules Document: BrowardNext to allow the issuance of a building permit after plat application and
